THE BOROUGH OF SOUTHEND-ON-SEA CENTRAL AREA AND SEAFRONT METER ZONE (CONSOLIDATION) ORDER 2001, AMENDMENT NO. 2 (EXPERIMENTAL RESTRICTION OF WAITING, LOADING AND UNLOADING) ORDER 2002

The Southend-on-Sea Borough Council (the Authority), in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. The Borough of Southend-on-Sea Central Area and Seafront Meter Zone (Consolidation) Order 2001 as amended, is hereby amended by:-
 - (a) the revocation of the items listed in Schedule 1 to this Order and;
 - (b) the addition of the items listed in Schedule 2 to this Order.

Other than the Amendments of this Order, The Borough of Southend-on-Sea Central Area and Seafront Meter Zone (Consolidation) Order 2001 as amended remains in full force and effect.

The Experimental Order will come into operation on 4 June 2002 and shall remain in force until 4 December 2003, during which time, from a period of not less than 6 months of the Experimental Order coming into force, the Council will monitor the scheme and consider representations made to it before deciding whether or not to introduce a permanent scheme.


