Southend-on-Sea Borough Council, in exercise of its powers conferred to it under Regulation 23 of the Local Authorities' Traffic Orders (Procedure)(England and Wales) Regulations 1996, and of all other enabling powers, hereby makes the following Order:

1. This Order may be cited as The Borough of Southend-on-Sea Central Area and Seafront Meter Zone (Consolidation) Order 2001 (Amendment No. 2) (Restriction Of Waiting, Loading And Unloading) Order 2002 and shall come into effect on 4 December 2003.
2. The Borough of Southend-on-Sea Central Area and Seafront Meter Zone (Consolidation) Order 2001 as amended is hereby amended by:-
(a) the revocation of the items listed in Schedule 1 to this Order; and
(b) the addition of the items listed in Schedule 2 to this Order.
3. The prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

Other than the Amendments of this Order, The Borough of Southend-on-Sea Central Area and Seafront Meter Zone (Consolidation) Order 2001 as amended remains in full force and effect.
