## The Borough of Southend-on-Sea ((Off-Street Parking Places) Consolidation Order 2005) (Amendment) Order 2006

The Southend-on-Sea Borough Council, in exercise of its powers under Sections 32, 33 and 35 (and part IV of Schedule 9) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), the Road Traffic Act 1991 (hereinafter referred to as "the 1991 Act") as modified by The Road Traffic (Permitted Parking Area and Special Parking Area)(Borough of Southend-on-Sea) Order 2001, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and the 1991 Act, hereby makes the following Order:-

- 1. This Order may be cited as The Borough of Southend-on Sea ((Off-Street Parking Places) Consolidation Order 2005) (Amendment) Order 2006 and shall come into operation on 23 November 2006.
- 2. The Borough of Southend-on Sea (Off-Street Parking Places) Consolidation Order 2005 (as amended) is hereby further amended by the amendment of paragraphs 3, 4 and 5 of Article 4 of Part II (Amount of Initial Charge at Parking Places) to the following:
  - "(3) Upon payment of the initial charge for the vehicle referred to in paragraph (2) of this Article the driver thereof shall exhibit on the vehicle, in accordance with the provisions of paragraphs (4) and (5) of this Article, a ticket issued by the ticket issuing parking meter.
  - (4) The ticket referred to in paragraph (3) of this Article must be exhibited at all times on the vehicle:-
    - (a) in the case of a two-wheeled motor cycle having a sidecar attached thereto in a conspicuous position on the nearside of the vehicle in front of the driving seat; and
    - (b) in the case of any other vehicle:-
      - (i) where the vehicle is fitted with a front glass windscreen extending across the vehicle to the nearside, facing forwards on the nearside of the glass of such windscreen behind the glass;
      - (ii) where the vehicle is not-fitted with a front glass windscreen as specified in (i) above, on the nearside of the vehicle facing towards the nearside of the road and not less than 75 cms and not more than 2 metres above the surface of the carriageway in the immediate vicinity.
  - (5) The ticket referred to in paragraph (3) of this Article must be continuously displayed and shall be so exhibited on the vehicle so that the time shown on the front of the said ticket is clearly visible to a person standing at the nearside of the vehicle."
- 3. The prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations

- made or having effect as if made under the Act of 1984 or by any other enactment.
- 4. Other than the amendments imposed by this Order, The Borough of Southend-on Sea (Off-Street Parking Places) Consolidation Order 2005 (as amended) remains in full force and effect.
- 5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
