

THE BOROUGH OF SOUTHEND-ON SEA
(Various Roads)(Consolidation of Waiting Restrictions) Order 2006
(AMENDMENT NO. 4) ORDER 2007

Road Traffic Regulation Act 1984

The Southend-on-Sea Borough Council made an Order on 6 August 2007 in exercise of its powers under Sections 1, 2, 4, 32, 35 and Section 84 (and part IV of Schedule 9) of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will amend the above-mentioned Order by the addition of those items in Schedule 1 below and the revocation of those items listed in Schedule 2 below. The Order will come into effect on 14 August 2007.

A copy of the sealed Order, a map showing the roads to which the Order relate and a statement of the Council's reasons for proposing to make the Order may be inspected at the office of the Contact Centre on the Ground Floor of the Civic Centre (address below) normal office hours.

If you wish to question the validity of the Order, or of any provision contained therein, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act of 1984, or on the grounds that any requirement of the Act, or of any instrument made under it, has not been complied with in relation to the Order, you may within six weeks from 6 August 2007 apply to the High Court for this purpose.

DB192	Park Street (Westcliff-on-Sea)	A disabled parking bay on the carriageway on the east side from a point on the east kerbline 1.7m north of the common boundary of Nos 22 & 24 Park Street northwards for a distance of 5.5m with a width throughout of 1.8 m	1
DB193	South Avenue	A disabled parking bay on the carriageway and the footway on the south side from a point 6.4m west of the common boundary of Nos 284 & 286 South Avenue westwards for a distance of 6m with a width throughout of 1.8m – 0.7m on the footway & 1.1m on the carriageway	1
DB194	St Marys Road	A disabled parking bay on the carriageway on the south side from a point 6.0m west of the common boundary of Nos 20 & 22 St Marys Road westwards for a distance of 6.0m with a width throughout of 1.8m	1
