

**THE BOROUGH OF SOUTHEND-ON SEA**  
**((Central Area and Sea Front Meter Zone) (Consolidation) Order 2005)(as amended)**  
**(AMENDMENT NO. 1 ) ORDER 2011**

The Southend-on-Sea Borough Council, in exercise of the powers conferred by sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 hereinafter referred to as the 1984 Act, and part 6 of the Traffic Management Act 2004 hereinafter referred to as the 2004 Act and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 of the act hereby makes the following Order:

1. This Order may be cited as The Borough of Southend-on-Sea ((Central Area and Sea Front Meter Zone) (Consolidation) Order 2005)(As Amended) (Amendment No. 1) Order 2011 and shall come into operation on 17<sup>th</sup> May 2011.
2. The prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.
3. Other than the amendments imposed by this Order, The Borough of Southend-on Sea ((Central Area and Seafront Meter Zone) (Consolidation) Order 2005 (as amended) remains in full force and effect.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. The following Articles of The Borough of Southend-on-Sea ((Central Area and Seafront Meter Zone) (Consolidation) Order 2005 (as amended) will be substituted with the Schedules to this Order.
  - (i) Article 31. Paragraphs (1), (2) and (3) (c);
  - (ii) Article 33. Paragraph (1)

## Schedule

### Amount of penalty charge at parking places

31. (1) If a vehicle is left in a prohibited or restricted road or a parking place without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable.

The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by under any other enactment.

31. (3) (c) Then penalty charge shall be paid to the Council in accordance with the instructions set out on the penalty charge notice;

- (i) A **reduced penalty charge may be** paid by the fourteenth day beginning with the date on which the penalty charge notice was served; or
- (ii) The **full penalty charge** must be paid no later than the last day of the period of twenty-eight days beginning with the date on which the penalty charge notice was served.
