

## STEVENAGE BOROUGH COUNCIL

### ROAD TRAFFIC REGULATION ACT 1984

#### **THE BOROUGH OF STEVENAGE (COREYS MILL LANE AND B197 NORTH ROAD, STEVENAGE) (ON STREET PAY AND DISPLAY AND PAY BY PHONE) ORDER 2016, BOROUGH OF STEVENAGE (TOWN CENTRE, STEVENAGE) (ON STREET PAY AND DISPLAY AND PAY BY PHONE) ORDER 2016 AND BOROUGH OF STEVENAGE (TOWN CENTRE, STEVENAGE) (ON STREET ELECTRIC VEHICLES' PAY AND DISPLAY AND PAY BY PHONE PARKING PLACES) ORDER 2020 (AMENDMENT) ORDER 2020**

Stevenage Borough Council, pursuant to the arrangements made under Section 19 of the Local Government Act 2000 with Hertfordshire County Council in exercise of their powers under Sections 32, 35, 45, 46, 46A, 47, 49 & 53 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of Schedule 9 of the Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

#### **Commencement & Citation**

1. This Order may be cited as "The Borough of Stevenage (Coreys Mill Lane and B197 North Road, Stevenage) (On Street Pay and Display and Pay by Phone) Order 2016, Borough of Stevenage (Town Centre, Stevenage) (On Street Pay and Display and Pay by Phone) Order 2016 and Borough of Stevenage (Town Centre, Stevenage) (On Street Electric Vehicles' Pay and Display and Pay by Phone Parking Places) Order 2020 (Amendment) Order 2020" and shall come into operation on 2 August 2020.
2. This Order amends The Borough of Stevenage (Coreys Mill Lane and B197 North Road, Stevenage) (On Street Pay and Display and Pay by Phone) Order 2016 and the Borough of Stevenage (Town Centre, Stevenage) (On Street Pay and Display and Pay by Phone) Order 2016 (herein after referred to as 'the Orders of 2016') and The Borough of Stevenage (Town Centre, Stevenage) (On Street Electric Vehicles' Pay and Display and Pay by Phone Parking Places) Order 2020 (herein after referred to as 'the Order of 2020') as specified in the Articles 3 and 4 of this Order.
3. In each of the Orders of 2016, there shall be inserted between Articles 23 1) and 2) the following Article:
  - 1A) If a Parking Ticket Machine is unable to accept payment of the initial charge due to breakdown, vandalism, or for any other reason, then payment of the initial charge must be made by telephone using the Telephone Payment System, if this requirement is indicated on the Parking Ticket Machine associated with a parking place.
4. In the Order of 2020, there shall be inserted between articles 25 1) and 2) the following Article:
  - 1A) If a Parking Ticket Machine is unable to accept payment of the initial charge due to breakdown, vandalism, or for any other reason, then payment of the initial charge must be made by telephone using the Telephone Payment System, if this requirement is indicated on the Parking Ticket Machine associated with a parking place.
5. The provision of the following Orders are hereby revoked only in so far as they are affected by the restrictions imposed by this Order:



"The Borough of Stevenage (Control of Parking) (Consolidation) Order 2017".
