## **ROAD TRAFFIC REGULATION ACT 1984**

## THE BOROUGH OF STEVENAGE (COREYS MILL LANE AND B197 NORTH ROAD, STEVENAGE) (PROHIBITION OF WAITING, LOADING OR UNLOADING) ORDER 2016 (AMENDMENT) ORDER 2018

Stevenage Borough Council, pursuant to the arrangements made under Section 19 of the Local Government Act 2000 with Hertfordshire County Council in exercise of their powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984, (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of Schedule 9 of the Act 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Borough of Stevenage (Coreys Mill Lane and B197 North Road, Stevenage) (Prohibition of Waiting, Loading or Unloading) Order 2016 (Amendment) Order 2018" and shall come into operation on 4 March 2019.

2. This Order amends The Borough of Stevenage (Coreys Mill Lane and B197 North Road, Stevenage) (Prohibition of Waiting, Loading or Unloading) Order 2016 (herein after referred to as 'the Order of 2016') as specified in Article 3 of this Order.

3. There shall be inserted in Schedule 1 (No waiting, loading or unloading at any time) of the Order of 2016 between items 8 and 9:

| 8A | Coreys Mill<br>Lane | South | From a point 23 metres west of its junction with the western kerb line of The Old Walled Garden westwards for a distance of 1 metre   |

4. The provision of the following Orders are hereby revoked only in so far as they are affected by the restrictions imposed by this Order: "The Borough of Stevenage (Coreys Mill Lane and B197 North Road, Stevenage) (On Street Pay and Display and Pay by Phone) Order 2016".
