ROMILEY APPENDIX A) (ONE WAY TRAFFIC EXCEPT CYCLES) ORDER 2025**

The Metropolitan Borough Council of Stockport, ("the Council") in exercise of its powers under Section 1(1) 2(1) to 3, 3(2) and 4(1) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following order:-

1. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. Save as provided in Article 3 and 4 of this Order there will be One Way Traffic (except for cycles) on the length of road specified in the Schedule to this Order.
3. Nothing in Article 2 of this Order shall apply if the vehicle is being used for fire brigade, ambulance or police purposes.
4. Nothing in Article 2 of this order shall render it unlawful to cause or permit any mechanical road cleansing vehicle or any refuse collection vehicle to enter the highway for so long as may be necessary to enable the vehicle to be used in the service of a Local Authority in pursuance of statutory powers or duties.

COMMENCEMENT & CITATION

5. This Order shall come into operation on the 2 April 2025 and may be cited as The Metropolitan Borough Council of Stockport (ATF4 Romiley Appendix A) (One Way Traffic Except Cycles) Order 2025.
