**THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT (A34 CORRIDOR
SCHEME, FOXLANDS ROAD /BROADWAY AREA, CHEADLE) (PROHIBITION
AND RESTRICTION OF WAITING) (SCHOOL CLEARWAY) AND (REVOCATION)
ORDER 2025**

The Metropolitan Borough Council of Stockport ("the Council") in exercise of its powers under Section 1 (1), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 as amended ("the 1984 Act"), and the Road Traffic Act 1991 as amended ("the 1991 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with 1991 Act, hereby makes the following Order:-

Interpretation

1. (1) In this Order:-

"Civil Enforcement Officer" means a person employed in accordance with section 63A of the 1984 Act as amended by the 2004 Act to carry out the functions referred to therein

"Disabled Persons" and "Disabled Person's Badge" have the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Disabled Persons' Vehicle" has the same meaning as section 142 of the 1984 Act and which is a vehicle, which immediately before or after any period of waiting, has been or is to be driven by a disabled person or, as the case may be, used for carrying Disabled Person(s) as passenger(s);

"Higher Level Contravention" means the contravention of this Order in respect of any of the Waiting and Loading restrictions of this Order.

"Lower Level Contravention" means the contravention of this Order in respect of any Articles of this Order other than the Waiting and Loading restrictions

"Owner" in relation to a vehicle means the person by whom the vehicle is kept. In determining who was the Owner at any time it shall be presumed that the Owner was the person who is named in the vehicle registration document as the registered keeper of a goods light goods or passenger vehicle or the person who has the use of such a vehicle in the course of his / her employment and who is entitled to use such a vehicle as though he / she were the registered keeper thereof;

"Parking Disc" means a disc, issued by a Local Authority, 125 millimetres square, coloured blue or orange and capable of showing the quarter hour period during which a period of waiting begins.

"Penalty Charge" has the same meaning as in section 82(1) of the 1991 Act and is £70 in respect of a Higher Level Contravention and £50 in respect of a Lower Level Contravention or such other charges as may be set by the Council under the provisions of section 77 of the 2004 Act in accordance with guidance given by the Secretary of State for Transport;

"Penalty Charge Notice" means a notice issued or served by a Civil Enforcement Officer pursuant to the provisions of section 72 of the 2004 Act;

"Relevant Position" in respect of a Disabled Person's Badge and Parking Disc has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000.

"School Keep Clear Area" means any area of carriageway of a specified road which is comprised within and indicated by a road marking.

"Specified Hours" means the hours between 8.00 a.m. and 5.00 p.m. on Monday to Friday;

"Specified Road" means any road or length of road specified in Schedule 1 to this Order.

- (2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- (3) Unless the context otherwise requires any reference in this Order to a numbered Article or Schedule is a reference to an Article or Schedule so numbered in this Order

Prohibition of Waiting

2. Save as provided in Articles 5 and 6 no person shall, except upon the direction or with the permission of a constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait at any time on the sides of lengths of road specified in Schedule 1

Restriction of Waiting

3. Save as provided in Articles 5 and 6, no person shall, except upon the direction or with the permission of a constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle to wait between the hours of 8.30 am to 9.30 am and 3.00pm to 4.30 pm Monday to Friday on the sides of length of road specified in Schedule 2.

School Clearway

4. Save as provided in Article 8 no person shall, except upon the direction or with the permission of a police constable in uniform, or Civil Enforcement Officer cause or permit any vehicle to stop or wait during the specified hours in a school keep clear area in the specified road detailed in Schedule 3.

Exemptions

- 5 Nothing in Articles 2 and 3 shall render it unlawful to cause or permit any vehicle to wait on the sides of lengths of road referred to in that Article for so long as may be necessary to enable:-
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said sides of lengths of road; or

- (iv) the laying, erection, alteration or repair, in or on land adjacent to the said sides of lengths of road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or a water authority in pursuance of statutory powers or duties;
 - (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 125 Postal Services Act 2000;
 - (e) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said sides of lengths of road;
 - (f) the vehicle to wait at or near to any premises situated on or adjacent to the said sides of lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
 - (g) the vehicle to be used for fire brigade, ambulance or police purposes; or
 - (h) goods to be loaded onto or unloaded from the vehicle.
- 6 Nothing in Articles 2 and 3 shall render it unlawful to cause or permit a disabled person's vehicle which displays, in the relevant position, a disabled person's badge, and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait on the side of lengths of road referred to in that Article for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of length of road on the same day).
- 7 Nothing in Article 3 of the Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait on the sides of lengths of road referred to therein.
- 8 Nothing in Article 4 of this Order shall render it unlawful for a person to cause or permit a vehicle to stop or wait in the school keep clear area:-
- (a) if the vehicle is being used for the removal of any obstruction to traffic;
 - (b) if the vehicle is being used in the service of a local authority or a water authority in the exercise of statutory powers or duties or in connection with the laying, erection, alteration or repair of any main, pipe or apparatus for the supply of gas or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984 and whilst being so used in such service or in such connection it is necessary for the vehicle to wait in that school keep clear area;
 - (c) if the vehicle is being used for police, fire brigade or ambulance purposes; or
 - (d) in any case where the person in control of the vehicle:
 - (i) is required by law to stop;
 - (ii) is obliged to stop so as to prevent an accident; or
 - (iii) is prevented from proceeding by circumstances beyond the driver's control.

9. The Council is satisfied that for avoiding danger to persons or other traffic using the roads to which Schedule 3 relates it is requisite that Section 3(1) of the Act shall not apply to this Order

CONTRAVENTION OF ORDER

10. **Contravention**

If a vehicle is left in a parking place during the permitted hours or in any road or length of road in contravention or without complying with the requirements of this Order a contravention shall have occurred and the Penalty Charge shall be payable and/or the vehicle may be removed from that location.

11. **Penalty Charge Notice**

In the case of vehicle in respect of which a Penalty Charge may have been incurred, it shall be the duty of a Civil Enforcement Officer to issue a Penalty Charge Notice which shall include the information required by the 1991 Act.

12. **Manner of payment of Penalty Charge**

The Owner of the vehicle in respect of which the Penalty Charge has been incurred shall pay the Penalty Charge to the Council as indicated on the Penalty Charge Notice.

13. **Indications as evidence**

The particulars given in the Penalty Charge Notice attached to a vehicle in accordance with this Article shall be treated as evidence in any proceedings relating to failure to pay such Penalty Charge.

14. **Removal of vehicle**

Where a Civil Enforcement Officer has removed or caused to be removed a vehicle in accordance with any Article of this Order:-

- 14.1 he / she shall provide for the safe custody of the vehicle;
- 14.2 the Council shall be entitled to recover from the person responsible such charges in respect of the removal, storage and disposal of the vehicle as it might prescribe from time to time;
- 14.3 the provisions of the 1984 Act as amended shall apply to the disposal of such vehicles removed by or on behalf of the Council pursuant to this Article.
- 14.4 Nothing in Article 10 or any other Article shall apply in respect of a vehicle displaying in a relevant position a valid Disabled Person's Badge.

15. **Restriction on removal of notices**

Where a Penalty Charge Notice has been attached to a vehicle in accordance with the provisions of Article 8 no person, not being the driver of the vehicle, a police constable in uniform, a Civil Enforcement Officer or some other person duly authorised by the Council, shall remove the notice from the vehicle unless authorised to do so by the driver.

16. Revocations

The restrictions in Schedule 4 to this Order are hereby revoked.

COMMENCEMENT & CITATION

16. This Order shall come into operation on the 18 April 2025 and may be cited as The Metropolitan Borough Council of Stockport (A34 Corridor Scheme Foxlands Road/Broadway, Cheadle) (Prohibition and Restriction of Waiting) (School Clearway) and (Revocation) Order 2025.

SCHEDULE 1 NO WAITING AT ANY TIME

Foxland Road, (South East Side): From a point 36 metres east from its intersection with the projected south-eastern kerb line of Delamere Road in an north-easterly direction for a distance of 14 metres. **Broadway**, (South East Side): From a point 8 metres west of its intersection with the projected north-western kerb line of Arlington Road to a point 14 metres east of its intersection with the north-eastern kerb line of Arlington Road. **Arlington Road**, (Both Sides): From the intersection of the projected south-eastern kerb line of Broadway in a south-easterly direction for a distance of 10 metres. **Broadway**, (North West Side): From a point 11 metres south-west from the projected north-western kerb line of Cherington Road in a north-easterly direction for a distance of 30 metres. **Broadway**, (South East Side): From a point 11 metres south-west of its intersection with the projected north-western kerb line of Cherington Road, in a north-easterly direction for a distance of 30.5 metres. **Cherington Road**, (Both Sides): From its intersection with the projected south-eastern kerb line of Broadway in a south-easterly direction for a distance of 10 metres. **Broadway**, (North West Side): From a point 9.5 metres south-west of the projected north-western kerb line of Barcheston Road in a north-easterly direction for a distance of 30.5 metres. **Broadway**, (South East Side): From a point 9.5 metres south-west of its intersection with the projected south-eastern kerb line of Barcheston Road in a north-easterly direction for a distance of 27 metres. **Barcheston Road**, (Both Sides): From its intersection with the projected south-eastern kerb line of Broadway in a south-easterly direction for a distance of 15 metres. **Broadway**, (North West Side): From a point 12 metres south-west of its intersection with the south-western kerb line of High Grove Road in a north-easterly direction for a distance of 31 metres. **Broadway**, (South East Side): From a point 12 metres south-west of its intersection with the projected south-western kerb line of High Grove Road in a north-easterly direction for a distance of 32.5 metres. **High Grove Road**, (Both Sides): From its intersection with the projected north-western kerb line of Broadway in a north-westerly direction for a distance of 10 metres. **Broadway**, (North West Side): From a point 10 metres south-west of its intersection with the south-western kerb line of Broadway Avenue in a north-easterly direction for a distance of 24.5 metres. **Broadway**, (South East Side): From a point 11 metres north-east of its intersection with the projected south-eastern kerb line of Broadway Avenue in a south-westerly direction for a distance of 27 metres. **Broadway Avenue**, (Both Sides): From its intersection with the north-western kerb line of Broadway in a north-westerly direction for a distance of 10 metres. **Broadway**, (North West Side): From a point 53 metres south-west of its intersection with the western kerb line of Wilmslow Road in a south-westerly direction for a distance of 52 metres. **Broadway**, (South East Side): From a point 16 metres south-west of its intersection with the projected north-western kerb line of Brookfield Crescent in a north-easterly direction to a

point 10 metres north-east of the projected north-eastern kerb line of Brookfield Crescent. **Brookfield Crescent, (Both Sides):** From the intersection of the projected south-eastern kerb line of Broadway in a south-easterly direction for a distance of 10 metres.

SCHEDULE 2

NO WAITING MONDAY – FRIDAY, 08:30am – 09:30am and 15.00pm-16:30pm

Broadway, (South East Side): From a point 8 metres south-west of its intersection with the north-western kerb line of Arlington Road to its intersection with the eastern kerb line of the A34 Kingsway.

Broadway, (North West Side): From a point 6.5 metres east from its intersection with the projected north-eastern kerb line of Arlington Road to its intersection with the eastern kerb line of the A34 Kingsway.

Broadway, (South East Side): From a point 14 metres north-east of its intersection with the projected north-eastern kerb line of Arlington Road in a north-easterly direction for a distance of 34 metres.

SCHEDULE 3

NO STOPPING MONDAY TO FRIDAY 8.00 AM TO 5.00 PM ON SCHOOL KEEP CLEAR MARKINGS

Foxland Road, (South East Side): From a point 50 metres east of the projected south-eastern kerb line of Delamere Road in a north-easterly direction for a distance of 87.5 metres.

Broadway, (North West Side): From a point 32.5 metres north-east of its intersection with the projected north-eastern kerb line of Arlington Road in a north-easterly direction for a distance of 25.56 metres.

SCHEDULE 4 REVOCATIONS

Revocation of No Waiting Monday to Friday 8.30-9.30am & 3-4.30pm Broadway, (South Side): From its intersection with the eastern kerb line of A34 Kingsway in an easterly direction to a point 47 metres east of its intersection with the eastern kerb line of Arlington Road. **Broadway (North Side):** From its intersection with the eastern kerb line of A34 Kingsway in an easterly direction for a distance of 145 metres. **Arlington Road, (Both Sides):** From its intersection with the southern kerb line of Broadway in a southerly direction for a distance of 5 metres. **Broadway, (South Side):** From a point 9 metres east from the eastern kerb line of Cherington Road in a westerly direction for a distance of 28 metres. **Cherington Road, (Both Sides):** From its intersection with the southern kerb line of Broadway in a southerly direction for a distance of 10 metres. **Barcheston Road, (Both Sides):** From its intersection with the south-east kerb line of Broadway in a southerly direction for a distance of 10 metres. **Revocation of No Stopping on School Entrance Markings Monday to Friday 8am to 5pm (School Keep Clear) Broadway, (North Side):** From a point 150 metres east from its intersection with the projected eastern kerb line of A34 Kingsway in an easterly direction for a distance of 25.5 metres. **Revocation of No Waiting At Any Time Broadway, (South-East Side):** From a point 10 metres west of the westerly kerb line of Barcheston Road to a point 10 metres east of the easterly kerb line of Barcheston Road. **Barcheston Road, (Both Sides):** From the south-east kerb line of Broadway for a distance of 15 metres in a southerly direction. **Broadway, (North-West side):** From a point 10 metres north-east of the eastern kerb line of Broadway Avenue in a south-westerly direction for a distance of 27 metres. **Broadway Avenue, (Both Sides):** From its intersection with the north-western kerb line of Broadway in a north-westerly direction for a distance of 10 metres.
