THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT (BUXTON ROAD, HAZEL GROVE, BUS GATE) (PROHIBITION OF MOTOR VEHICLES EXCEPT FOR LOCAL BUSES) ORDER 2018

The Council of the Metropolitan Borough of Stockport, ("the Council") in exercise of its powers under Section 1(1) 2(1) to 3, 3(2) and 4(1) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act hereby makes the following order:-

INTERPRETATION

1. (1) In this Order:-

"Bus", for the purposes of this Order means a public service vehicle used for the provision of a Local Service, an Excursion or a Tour.

"Local Service" has the same meaning as Section 2 of the Transport Act 1985;

(2) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

PROHIBITION OF ENTRY EXCEPT FOR BUSES, TAXIS AND CYCLES

2. No person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle other than a Bus to enter the highways referred to in Schedule 1. Pedal Cycles and Horses are exempt from this Order.

COMMENCEMENT & CITATION

3. This Order shall come into operation on the 20th day of October 2018 and may be cited as The Metropolitan Borough Council of Stockport (Buxton Road, Hazel Grove, Bus Gate) (Prohibition of Motor Vehicles Except for Local Buses) Order 2018.

SCHEDULE 1

PROHIBITION OF MOTOR VEHICLES EXCEPT FOR LOCAL BUSES

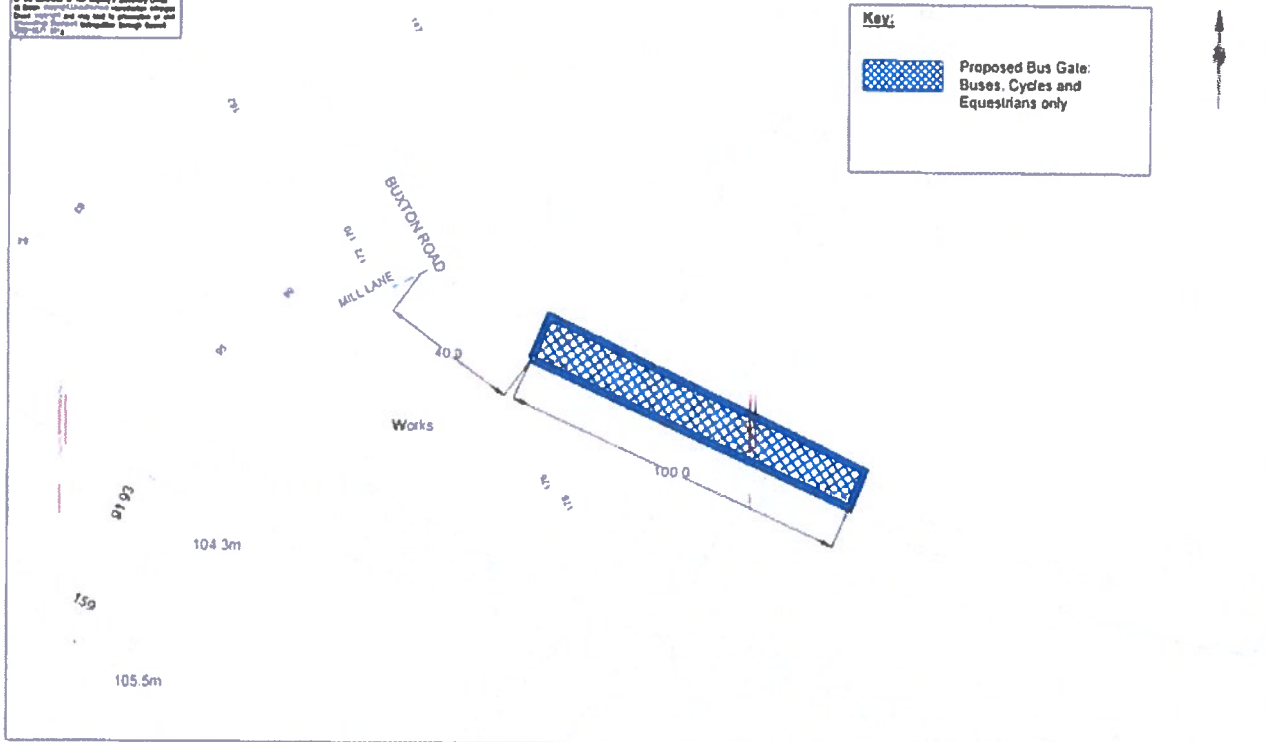
Buxton Road, both directions, from a point 40 metres southeast of the projected south-easterly kerbline of Mill Lane, for a distance of 100 metres in a south-easterly direction.

The Metropolitan Borough Council of Stockport ('the Council') in exercise of the powers under Sections 32(1) and 35(1) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), the Road Traffic Act 1991 ("the 1991 Act") and the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the 1991 Act, hereby makes the following Order:-

1. The Interpretation Act 1978 shall apply for interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. The heading of Article 2 of THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT (BUXTON ROAD, HAZEL GROVE, BUS GATE) (PROHIBITION OF MOTOR VEHICLES EXCEPT FOR LOCAL BUSES) ORDER 2018 which states **PROHIBITION OF ENTRY EXCEPT FOR BUSES, TAXIS AND CYCLES**

Is hereby amended to state:

PROHIBITION OF ENTRY EXCEPT FOR BUSES, HORSES AND CYCLES
