THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT ("the Council") in exercise of the powers conferred by Sections 82(2) and 84(1) of the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

- 1. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. Save as provided in Articles 3 and 4 of this Order no person shall, except under the direction or with the permission of a constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle except for a taxi to stop on the highway referred to in the schedule to this Order.
- 3. Nothing in Article 2 of this order shall apply if the vehicle is being used for Fire Brigade, Ambulance or Police purposes.
- 4. Nothing in Article 2 of this order shall render it unlawful to cause or permit any mechanical road cleansing vehicle or any refuse collection vehicle to enter the highway from its junction with for so long as may be necessary to enable the vehicle to be used in the service of a Local Authority in pursuance of statutory powers or duties.

COMMENCEMENT & CITATION

6. This Order shall come into operation on the 10 April 2025 and will expire on 10 October 2026 unless the Council determines to make the Order permanent an may be cited as The Metropolitan Borough Council of Stockport (Stockport Town Centre) (No Stopping except for Taxis) Experimental Order 2025.
