(AMENDMENT) ORDER 2022**

The Metropolitan Borough Council of Stockport ('the Council') in exercise of the powers under Sections 32(1) and 35(1) of the Road Traffic Regulation Act 1984 ('the 1984 Act'), the Road Traffic Act 1991 ('the 1991 Act') and the Traffic Management Act 2004 ('the 2004 Act') and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the 1991 Act, hereby makes the following Order:-

1. The Interpretation Act 1978 shall apply for interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. In the Schedule to The Metropolitan Borough Council of Stockport (Hardy Drive, Boston Close, Robins Lane, Glenholme Road and Convaamore Road, Bramhall) (Prohibition of Waiting Order 2022 Hardy Drive (North East Side) From the intersection of the north western kerb line of Robins Lane, heading in a north westerly direction to a point 10 meters north west of the intersection of the eastern kerb line of Boston Close is hereby amended to read Hardy Drive (North East Side) From the intersection of the north western kerb line of Robins Lane, heading in a north westerly direction to the easterly projected kerb line of Boston Close.
3. This Order shall come into operation on the 18 March 2022 and may be cited as The Metropolitan Borough Council of Stockport The Metropolitan Borough Council of Stockport (Hardy Drive, Boston Close, Robins Lane, Glenholme Road and Convaamore Road, Bramhall) (Prohibition of Waiting Order 2022 (Amendment) Order 2022
