## **THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT (HEATON LANE, STOCKPORT) (BUS GATE) AND (REVOCATION) ORDER 2021**

---

The Metropolitan Borough Council of Stockport ('the Council') in exercise of its powers under Sections 1(1), 2(1), to (3) and 4(2) of the Road Traffic Regulation Act 1984, ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1 (1) In this Order:-

"Bus" for the purposes of this Order means a public service vehicle used for the provision of a Local Service, an Excursion or a Tour.

"Local Service" has the same meaning as Section 2 of the Transport Act 1985.

"Cycle" has the same meaning as in Section 192(1) of the Road Traffic Act 1988.

"Hackney Carriage" means a hackney carriage licensed by a Local Authority to ply for hire.

(2) The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

### **PROHIBITION OF ENTRY EXCEPT FOR BUSES HACKNEY CARRIAGES AND CYCLES**

2. No person shall, except upon the direction of a Police Constable in uniform or of a Civil Enforcement Officer cause or permit any vehicle than a Bus to enter the highway referred to in the schedule to this Order, hackney carriages and cycles are exempted from this Order.

### **REVOCATION**

3. The Metropolitan Borough Council of Stockport (Heaton Lane, Stockport) (Bus/Taxi/Cycle Lane) Order 2021 is hereby revoked.

### **COMMENCEMENT & CITATION**

3. This Order shall come into operation on the 17 September 2021 and may be cited as The Metropolitan Borough Council of Stockport (Heaton Lane, Stockport) (Bus Gate) and (Revocation) Order 2021.

**SCHEDULE 1**

**PROHIBITION OF ENTRY EXCEPT FOR BUSES, HACKNEY CARRIAGES AND CYCLES**


Heaton Lane (West Bound) from a point 12 metres west of the intersection of the Western kerbline of Astley Street for a distance of 5 metres in an westerly direction.


Heaton Lane (East Bound) from a point 11 metres east of the intersection of the Eastern kerbline of Astley Street for a distance of 5 metres in an easterly direction.


