**THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT (REDROCK,
STOCKPORT) (PROHIBITION OF DRIVING) ORDER 2018**

THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT ("the Council") in exercise of the powers conferred by Sections 1(1), and 2(1) to (3) of the Road Traffic Regulations Act 1984 as amended ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984, hereby makes the following Order:-

1. No person shall, except upon the direction or with the permission of a constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle other than a pedal cycle to proceed along that length of road specified in Schedule 1 to this Order.
2. No person shall, except upon the direction or with the permission of a constable in uniform or of a Civil Enforcement Officer, cause or permit any vehicle other than a pedal cycle, bus or Hackney Carriage, or any vehicle for the purposes of loading/unloading, to proceed along that length of road specified in Schedule 2 to this Order.
3. Police, Fire and Ambulance services are exempt from this Order.
4. The Interpretation Act 1978 shall apply for interpretation of this Order as it applies for the interpretation of an Act of Parliament.

COMMENCEMENT & CITATION

5. This Order shall come into operation on the 20th October 2018 and may be cited as The Metropolitan Borough Council of Stockport (Redrock, Stockport) (Prohibition of Driving) Order 2018.

SCHEDULE 1

Prohibition of Driving

Brown Street, both sides between Bridgefield Street and Prince's Street in both directions.

Woodman Street, both sides between Bridgefield Street and Prince's Street in both directions.

SCHEDULE 2

Prohibition of Vehicles Except for Loading/Unloading, Buses, Hackney Carriages and Cycles Port Street, at its junction with Great Egerton Street.
