## THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT (TIVIOT DALE AND DANIELS LANE, STOCKPORT) (REVOCATION) ORDER 2017

THE COUNCIL of the METROPOLITAN BOROUGH OF STOCKPORT ("the Council") in exercise of its powers under Sections 1(1), and 2(1) to (3) and Part (IV) of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultations with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. The Interpretation Act 1978 shall apply for interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The restrictions referred to in Column 1 of the Schedule to this Order, as depicted on the Plan marked with the Area Code referred to in Column 2 of the Schedule and as appended to the Metropolitan Borough Council of Stockport (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2010 are hereby deleted from that Order and from any other Order in which the restrictions referred to in Column 1 of the Schedule are referred to.
- 3. This Order shall come into operation on the 5 May 2017 and may be cited as The Metropolitan Borough Council of Stockport (Tiviot Dale and Daniels Lane, Stockport) (Revocation) Order 2017

de-sac for a distance of 4 metres in a westerly direction.	

Tiviot Dale Easterly cul-de-sac, north side from a point 22 metres west of the projected westerly kerb line of Tiviot Dale northerly cul-de-sac for a distance of 12 metres in a westerly direction. Daniel's Lane Both sides, between its junction with Tiviot Dale for its entire length including its cul de-sac end.

Revoke No Waiting at Any Time Except Taxis, Tiviot Dale East side from a point 37 metres north of the northerly kerb line of Percy Street for a distance of 17 metres in a northerly direction. Tiviot Dale East side from a point 7.5 metres north of the northerly kerb line of Percy Street for a distance of 5.5 metres in a northerly direction.

Revoke Pay and Display Parking Tiviot Dale, Westerly cul-de-sac, north side from a point 4 metres west of the projected westerly kerb line of Tiviot Dale northerly cul-de-sac turning head for a distance of 18 metres in a westerly direction. Tiviot Dale, westerly cul-de-sac, north side from a point 34 metres west of the projected westerly kerb line of Tiviot Dale northerly cul-de-sac turning head for a distance of 20 metres in a westerly direction and the turning head return. Tiviot Dale, east side from a point 54 metres north of the northerly kerb line of Percy Street for a distance of 23 metres in a northerly direction. Tiviot Dale, west side from a point 12 metres north of the northerly kerb line of Prince's Street for a distance of 16 metres in a northerly direction.
