THE COUNCIL of the METROPOLITAN BOROUGH OF STOCKPORT ("the Council") in exercise of its powers under Sections 1(1), and 2(1) to (3) and Part (IV) of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultations with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

- 1. The Interpretation Act 1978 shall apply for interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. The Metropolitan Borough Council of Stockport (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2010 is hereby varied to include cashless parking as payment for a parking place as an alternative to inserting coins into a ticket machine the driver of the vehicle shall telephone the number displayed on the relevant signs and shall pay for the requisite time for parking by way of credit or debit card.
- 3. If at any time while a vehicle is left in a cashless parking place and no record of a cashless parking place payment has been received the relevant charge shall be deemed not to have been paid unless the contrary is proved.
- 4. The expiry of the period of time for which the charge has been paid for the relevant parking place shall be indicated by a recorded cashless parking payment which shows that the amount of time which has been paid for a parking place has expired.
- 5. If a vehicle is left in a cashless parking place without payment of the charges specified on the relevant signs a contravention shall have occurred and a penalty charge shall be payable and/or the vehicle may be moved from that location.
- 6. This Order shall come into operation on the 16th August 2012 and may be cited as The Metropolitan Borough Council of Stockport (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2010) (Variation (No 2)) Order 2012
