THE METROPOLITAN BOROUGH COUNCIL OF STOCKPORT ("the Council") in exercise of the powers conferred by Sections 1(1) and (2), 2(1) to (3) and 3(2) of the Road Traffic Regulations Act 1984 as amended ("the 1984 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:-

1. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2. Save as provided in Articles 3 and 4 of this Order no person shall, except under the direction or with the permission of a constable in uniform or of a Civil Enforcement Officer, cause or permit any motorised vehicle to enter the highway referred to in the schedule to this Order .
3. Nothing in Article 2 of this order shall apply if the vehicle is being used for Fire Brigade, Ambulance or Police purposes.
4. Nothing in Article 2 of this order shall render it unlawful to cause or permit any mechanical road cleansing vehicle or any refuse collection vehicle to enter the highway referred to in the Schedule to this Order for so long as may be necessary to enable the vehicle to be used in the service of a Local Authority in pursuance of statutory powers or duties.

**COMMENCEMENT & CITATION**

6. This Order shall come into operation on the 25 April 2025 and may be cited as The Metropolitan Borough Council of Stockport (Whitehill Primary School, Heaton Norris) (Prohibition of Entry for Motorised Vehicles) Order 2025.

**SCHEDULE  
PROHIBITION OF ENRTY FOR MOTORISED VEHICLES**

<b>Selby Street</b> , (North East bound): From a point 5 metres north-east of its intersection with the north-eastern kerb line of Park Bridge Close in a north-easterly, then south-easterly direction for a distance of 119 metres to its intersection with the north-western kerb line of Horace Grove.
