CITY OF STOKE-ON-TRENT (TRAFFIC REGULATION) (NO. 23) AMENDMENT (NO. 2) 2002 RESIDENTS PARKING

THE COUNCIL OF THE CITY OF STOKE-ON-TRENT in exercise of its powers under Section 1(1) and (2), 2(1) to (3), 4(2), 45 AND 46 of the Road Traffic Regulation Act, 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKES THE FOLLOWING ORDER:-

- 1. The lengths of road as specified in Schedules One to Nine hereto are hereby designated as parking spaces for the parking only of vehicles in accordance with Part IX of the City of Stoke-on-Tren(Traffic Regulation) (No. 5) Consolidation Order 2002 (as amended) ("the Original Order").
- 2. The provisions of the Original Order shall apply to this Order as if the lengths of road specified in Schedules One to Nine hereto had been added to the respective Parts of Part IX of the Original Order and the respective Schedules of the Original Order thereby making the said lengths of road parking places in accordance with the provisions of the Original Order.
- 3. The Interpretation Act, 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

4. This Order shall come into operation on the 15th day of 2002 and may be cited as "City of Stoke-on-Trent (Traffic Regulation) (No. 23) Amendment (No. 2) 2002 Residents Parking".
