THE COUNCIL OF THE CITY OF STOKE-ON-TRENT in exercise of its powers under Se Sections 1(1) and (2), 2(1) to (3) and 4(1) and (2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKE THE FOLLOWING ORDER :-

- 1. Save as provided in Article 3 of this Order no person shall cause or permit any vehicle to be driven in the length of road specified other than in the direction stated in the First Schedule hereto;
- 2. Save as provided in Articles 3 and 4 of this Order no person shall cause or permit any vehicle at any time to wait, load or unload in the lengths of road specified in the Second Schedule hereto;
- 3. Nothing in this Order shall apply to anything done upon the direction or with the permission of a Police Officer in uniform.
- 4. Nothing in Article 2 of this Order shall render it unlawful to cause or permit a vehicle to wait in the lengths of road referred in that article for so long as may be necessary ;-
- a) to enable the vehicle if it cannot conveniently be used for such purposes in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so referred to, or the laying, erection, alteration or repair in or near to the said road of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication apparatus kept installed for the purposes of a telecommunication code system or with any service provided by means of any such apparatus as defined in the Telecommunication Act, 1984;
- 5. The interpretation Act, 1978 shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.
- 6. This Order shall come into operation on the 2nd day of March 2004 and may be cited as "City of Stoke-on-Trent (Traffic Regulation) (Tower Square) (No.11) Order 2004".
