<u>CITY OF STOKE-ON-TRENT (TRAFFIC REGULATION) (VARIOUS PROVISIONS)</u> (NO.16) ORDER, 2006

THE COUNCIL OF THE CITY OF STOKE-ON-TRENT in exercise of its powers under Sections 1, 2, 4, 45, 46 and 49 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKE THE FOLLOWING ORDER:-

GENERAL

In this Order:-

"disabled persons badge" shall have the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000, as amended by the Disabled Persons (Badges for Motor Vehicles) (England) (Amendment) Regulations 2000.

"disabled persons vehicle" means a vehicle displaying a valid disabled persons badge in accordance with the circumstances prescribed in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"driver" in relation to a vehicle waiting in any road or length of road, street or highway means the person driving the vehicle at the time it was left in that location

"relevant position" means in relation to disabled persons badges or discs exhibited on the dashboard or facia of the vehicle or if the vehicle does not have a dashboard or facia exhibited in a conspicuous position on the vehicle so that the front of the badge or disc is clearly legible from the outside of the vehicle;

PART I

AMENDMENTS TO THE CITY OF STOKE-ON-TRENT (TRAFFIC REGULATION) (No.5) CONSOLIDATION ORDER 2002 and CITY OF STOKE ON TRENT (TRAFFIC REGULATION) (VARIOUS RESIDENTS PARKING SCHEMES) (No.111) ORDER 2005

- 1. To add the lengths of road specified in the First Schedule hereto to Zone STAD2 within Part VII of the City of Stoke-on-Trent (Traffic Regulation) (No.5)(Consolidation Order 2002) "The Consolidation Order" [Controlled Parking Britannia Stadium Scheme] and thereby each length of road is to be used only in accordance with the provisions of that Scheme during the regulated hours that are specified and in relation to Zone STAD2.
- 2. To add the lengths of road specified in the Twenty Second Schedule hereto to the One Hundredth and Twenty First Schedule of the City of Stoke-on-Trent (Traffic Regulation) (No.5) Consolidation Order, 2002. "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of "The Consolidation Order".

- 3. To create a designated permit parking area in the lengths of road specified in the Twenty Third Schedule hereto and add the respective zone B5 to Part B of Part IX of the City of Stoke-on-Trent (Traffic Regulation) (No.5) Consolidation Order 2002 "The Consolidation Order" and thereby each length of road is to be used only in accordance with the provisions of the schemes in that Part of the consolidated order.
 - a. To allow the property specified in the Thirty Second Schedule to obtain one Business Permit to leave a vehicle in the zone referred to in Article 3 above, following the payment of a fee as stated in section 3 of Part X of the City of Stoke-on-Trent (Traffic Regulation) (No.5) Consolidation Order 2002 "The Consolidation Order".
- 4. To create a designated permit parking area Zone H16 in the lengths of road specified in the Twenty Fourth Schedule hereto, and add the lengths of road to the Fifth Schedule of City of Stoke-on-Trent (Traffic Regulation) (Various Residents Parking Schemes) (No.111) Order 2005 and thereby each length of road is to used only in accordance with the provisions of that Order during the regulated hours that are specified and in relation to Zone H16.
- 5. To add the lengths of road specified in the Twenty Fifth Schedule hereto to the One Hundredth and Twenty Eighth Schedule of the City of Stoke-on-Trent (Traffic Regulation) (No.5) Consolidation Order, 2002. "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".
- 6. To add the lengths of road specified in the Twenty Sixth Schedule hereto to the One Hundredth and Twenty Eighth Schedule of "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".
- 7. To add the lengths of road specified in the Twenty Seventh Schedule hereto to the One Hundredth and Forty Ninth Schedule of "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".
- 8. To add the lengths of road specified in the Twenty Eighth Schedule hereto to the One Hundredth and Fifty Second Schedule of "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".
- 9. To add the lengths of road specified in the Twenty Ninth Schedule hereto to the One Hundredth and Fifty Third Schedule of "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".
- 10. To add the lengths of road specified in the Thirtieth Schedule hereto to the One Hundredth and Fifty Fifth Schedule of "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".
- 11. To add the lengths of road specified in the Thirty First Schedule hereto to the One Hundredth and Fifty Sixth Schedule of "The Consolidation Order" and thereby each length of road is to used only in accordance with the provisions of that schedule within "The Consolidation Order".

PART II MISCELLANEOUS RESTRICTIONS

- 1. Save as provided for in Articles 1 and 2 (a), (c), (e) and 4 of Part III of this Order no person shall cause or permit any vehicle other than a disabled persons vehicle to wait at any time in the lengths of road specified in the Second Schedule hereto and the said lengths of road are hereby designated as disabled parking places.
- 2. Save as provided for in Articles 1 and 2 (a), (c), (e) and 3 of Part III of this Order no person shall cause or permit any vehicle other than a disabled persons vehicle to wait in excess of 3 Hours, no return within 1 Hour at any time in the lengths of road specified in the Third Schedule hereto and the said lengths of road are hereby designated as disabled parking places.
- 3. Save as provided for in Articles 1 and 2 (a), (c), (d), (e) of Part III of this Order no person shall cause or permit the waiting of any vehicle at any time in the length of road specified in the Fourth Schedule hereto save for Doctors displaying a valid permit issued by the Council in the relevant position and the said length of road is hereby designated as a Doctors parking place.
- 4. Save as provided for in Articles 1, 2 and 4 of Part III of this Order no person shall cause or permit the waiting of any vehicle in the lengths of road specified in the Fifth Schedule hereto for a period in excess of 1 Hour return prohibited within 1 Hour between the hours of 8.00a.m. to 6.00p.m. Monday to Friday Inclusive.
- 5. Save as provided for in Articles 1, 2 and 4 of Part III of this Order no person shall cause or permit the waiting of any vehicle in the lengths of road specified in the Sixth Schedule hereto for a period in excess of 1 Hour return prohibited within 1 Hour between the hours of 8.00a.m. to 6.00p.m. Monday to Saturday Inclusive.
- 6. Save as provided for in Articles 1, 2 and 4 of Part III of this Order no person shall cause or permit the waiting of any vehicle in the lengths of road specified in the Seventh Schedule hereto for a period in excess of 2 Hours, return prohibited within 1 Hour between the hours of 8.00a.m. to 6.00p.m. Monday to Saturday Inclusive.
- 7. Save as provided for in Articles 1, 2 and 4 of Part III of this Order no person shall cause or permit the waiting of any vehicle in the lengths of road specified in the Eighth Schedule hereto for a period in excess of 2 Hours return prohibited within 1 Hour between the hours of 8.00a.m, to 9.00p.m. Monday to Saturday Inclusive.
- 8. Save as provided for in Articles 1, 2 and 4 of Part III of this Order no person shall cause or permit the waiting of any vehicle in the lengths of road specified in the Ninth Schedule hereto for a period in excess of 90 minutes Hour return prohibited within 1 Hour between the hours of 9.00a.m. to 5.00p.m. Monday to Saturday Inclusive.
- 9. Save as provided for in Articles I and 2 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Tenth Schedule hereto except for the purposes of loading and unloading at anytime, and hereby designate the said length of road as a loading bay.

- 10. Save as provided for in Articles 1 and 2 (a), (c), (d), (e) of Part III of this Order no person shall cause or permit any vehicle to wait for the purposes of loading and unloading between the hours of 9.00a.m. and 5.00p.m.in the lengths of road specified in the Eleventh Schedule hereto
- 11. Save as provided for in Articles 1, 2 (c), (d), (e) of Part III of this Order no person shall cause or permit any vehicle to stop at anytime on Entrance Markings in the lengths of road specified in the Twelfth Schedule hereto
- 12. Save as provided for in Articles 1, 2 (c), (d), (e) of Part III of this Order no person shall cause or permit any vehicle to stop at anytime on Entrance Markings between the hours of 8.00am and 5.00pm in the lengths of road specified in the Thirteenth Schedule hereto
- 13. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait at any time in the lengths of road specified in the Fourteenth Schedule hereto.
- 14. Save as provided for in Articles 1, 2 (a), (c), (e), (f) of Part III of this Order no person shall cause or permit any vehicle to wait, load and unload at anytime in the lengths of road specified in the Fifteenth Schedule hereto
- 15. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Sixteenth Schedule hereto between the hours of 8.30a.m. to 9.30a.m. and 2.30p.m. to 3.30p.m. Monday to Friday Inclusive.
- 16. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Seventeenth Schedule hereto between the hours of 8.30a.m. to 9.30a.m. and 3.00p.m. to 4.00p.m. Monday to Friday Inclusive.
- 17. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Eighteenth Schedule hereto between the hours of 8.00a.m. to 9.00a.m. and 2.30p.m. to 3.30p.m. Monday to Friday Inclusive.
- 18. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Nineteenth Schedule hereto between the hours of 10.00a.m. and 8.00p.m. Monday to Saturday Inclusive.
- 19. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Twentieth Schedule hereto between the hours of 8.00a.m. and 6.00p.m. Monday to Saturday Inclusive.
- 20. Save as provided for in Articles 1, 2 and 3 of Part III of this Order no person shall cause or permit any vehicle to wait in the lengths of road specified in the Twenty First Schedule hereto between the hours of 8.00a.m. and 8.00p.m. Monday to Saturday Inclusive.

PART III GENERAL EXEMPTIONS

- 1. Nothing in this Order shall apply to anything done upon the direction or with the permission of a Police Officer in uniform.
- 2. Nothing in Articles 1 to 20 of Part II of this Order shall render it unlawful to cause or permit a vehicle to be wait in the lengths of road referred to in that Article for as long as may be necessary:
 - a) to enable a person to board or alight from the vehicle;
 - b) to enable goods to be loaded onto or unloaded from a vehicle;
 - c) to enable the vehicle if it cannot conveniently be used for such purposes in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so referred to, or the laying, erection, alteration or repair in or near to the said road of any sewer or any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunication apparatus kept installed for the purposes of a telecommunication code system or with any service provided by means of any such apparatus as defined in the Telecommunication Act, 1984;
 - d) to enable the vehicle if it is in the service of or employed by the Post Office, to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
 - e) to enable the vehicle if it cannot be used for such purposes in any road, to be used in pursuance of statutory powers and duties
- 3. Nothing in Articles 12, 14, 15, 16, 17, 18 and 19 of Part II of this Order shall apply to prevent any disabled person's vehicle from waiting for a period of three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same road or part of road on the same day) provided that:
 - a) a disabled person's badge is displayed in the relevant position on the vehicle, in accordance with the Disabled Persons (Badges for Motor Vehicles) Regulations, 2000.

and

b) a disabled persons parking disc issued by a local authority is displayed in a relevant position on the vehicle and the person in charge of the said vehicle marks on the said parking disc the time at which the period of waiting has begun.

- 4. Nothing in Articles 2, 13, 15, 16, 17, 18, 19 and 20 of Part II of this order shall apply to prevent any disabled person's vehicle waiting for an unlimited period provided that:
 - a) a disabled person's badge is displayed in the relevant position on the vehicle, in accordance with the Disabled Persons (Badges for Motor Vehicles) Regulations, 2000.

and

- b) a disabled persons parking disc issued by a local authority is displayed in a relevant position on the vehicle and the person in charge of the said vehicle marks on the said parking disc the time at which the period of waiting has begun.
- 5. To revoke those parts of the Orders specified in the Schedule of Revocations hereto and hereby amend these Orders accordingly
- 6. The Interpretation Act, 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
- 7. This Order shall come into operation on the 5th day of February 2007 and may be cited as "City of Stoke-on-Trent (Traffic Regulation) (Various Provisions) (No.16) Order, 2006".
