CITY OF STOKE-ON-TRENT (MULBERRY STREET AREA, HANLEY) (TRAFFIC REGULATION) (NO.27) ORDER, 2009

THE COUNCIL OF THE CITY OF STOKE-ON-TRENT in exercise of its powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act HEREBY MAKE THE FOLLOWING ORDER:

- 1. Save as provided for in Article 5 of this Order no person shall cause or permit any vehicle to gain entry in the manner stated in the lengths of road specified in the First Schedule hereto;
- 2. Save as provided for in Article 5 of this Order no person shall cause or permit any vehicle to make a left turn manoeuvre in the length of road and in the manner specified in the Second Schedule hereto;
- 3. Save as provided for in Article 5 and of this Order no person shall cause or permit any vehicle to make a right turn manoeuvre in the length of road and in the manner specified in the Third Schedule hereto;
- 4. Save as provided for in Article 5 of this Order no person shall cause or permit any vehicle to be driven in the lengths of road except in the permitted direction as specified in the Fourth Schedule hereto;
- 5. Nothing in this Order shall apply upon the direction or with the permission of a police officer in uniform.
- 6. The Interpretation Act, 1978 shall apply for the interpretation of this Order as it applied for the interpretation of an Act of Parliament.
- 7. This Order shall come into operation on the 1st day of October 2009 and may be cited as "City of Stoke-on-Trent (Mulberry Street Area) (Traffic Regulation) (No.27) Order, 2009".
