# (DISTRICT OF STRATFORD ON AVON) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO.1) ORDER 2005

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

- 1. The Warwickshire County Council (District of Stratford on Avon) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004 (which said Order of 2004 is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
- 2. In Article 2 to the Principal Order, delete the entire paragraph commencing with the words "access way".
- 3. In Article 2 to the Principal Order, after the paragraph commencing with the words "goods vehicle" insert:-

"home carer" means a person employed by or on behalf of Warwickshire County Council Social Services Department providing care in the home for a resident and to whom a home carer's permit has been issued;

"home carer's permit" means a permit issued to a home carer by Stratford on Avon District Council:

4. In Article 2 to the Principal Order, after the paragraph commencing with the word "plans" insert:-

"registered guest house" means a guest house which has been inspected and graded by The Heart of England Tourist Board or the AA or the RAC and is a member of South Warwickshire Tourism and is located within the town of Stratford-upon-Avon;

- 5. In Article 2 to the Principal Order, in the paragraph commencing with the word "resident", delete the words "on the plans" and replace with the words "in the Schedules to this Order;
- 6. In Article 2 to the Principal Order, after the paragraph commencing with the words "Stratford on Avon District" insert:-

"temporary resident" means a person who is temporarily resident at a registered guest house;

7. In Article 8 to the Principal Order, delete the words "Articles 9 to 12" and replace with the words "Articles 9 to 12(a)".

- 8. After Article 12 to the Principal Order, insert:-
  - 12(a) Nothing in Article 8 of this Order shall render it unlawful for a motor car or motor cycle to be parked on a footway where such footway has been designated as a parking place under Article 13(1) of this Order and where such parking place is indicated by signs complying with Diagrams 668 and 668.2 of the 2002 Regulations.
- 9. Delete Article 15(2) to the Principal Order.
- 10. In Article 18(d) to the Principal Order, delete the words "21(2) or 21(4)" and replace with the words "21(2), 21(4) or 21(6)(b)".
- 11. After Article 19(1)(xi) to the Principal Order, insert:-
  - (xii) if the vehicle is being used by a home carer when visiting premises near to the parking place to provide care in the home for a resident and the vehicle displays a home carer's permit;
- 12. After Article 21(6) to the Principal Order, insert:-
  - (6)(a) The proprietor of a registered guest house may apply to the Council for the issue of a permit for use by a temporary resident for the leaving of a motor car or motor cycle in a parking place. Any such application shall be made on a form issued by and obtainable from the Council, shall specify whether the permit is required in respect of Zone S2, Zone S3, Zone S4 or Zone S8 (as detailed in the Schedule to this Order) and shall be accompanied by a remittance for such charge as provided by Article 22(3).
  - (6)(b) On receipt of an application made under the foregoing provision of this Article and the fee, the Council shall issue to that applicant a permit for the leaving of any motor car or motor cycle in any parking place to which such permit relates by a temporary resident.
- 13. After Article 22(2) to the Principal Order, insert:-
  - (3) The charge in connection with the issue of a permit under Article 21(6)(a) shall be three pounds and the permit shall be valid for a period of twenty four hours commencing from the time when the permit is issued to a temporary resident.
- 14. In Article 23(1) to the Principal Order, after the word "doctor" insert the words "and paragraph 3(c) of this Article in respect of a permit issued to a proprietor of a registered guest house".
- After Article 23(3)(b)(iii) to the Principal Order, insert:-
  - (3)(c) The events referred to in the foregoing provisions of this Article are, in respect of a permit issued to a proprietor of a registered guest house:-
    - (i) the permit holder ceasing to be a proprietor of a registered guest house.

- 16. In Article 23(4) to the Principal Order, delete the words "(3a) or (3b)" and replace with the words "(3a), (3b) or 3(c)".
- 17. After Article 26(3) to the Principal Order, insert:-
  - (3a) in the case of a permit issued under the provisions of Article 21(6)(b) the words "Temporary Resident's Parking Permit";
- 18. In Article 26(6) of the Principal Order, delete the words "Articles 21(2) and 21(4)" and replace with the words "Articles 21(2), 21(4) and 21(6)(b)".
- 19. In Article 26(6) of the Principal Order, after the word "relates" insert the words "in accordance with the Schedule to this Order".
- 20. In Article 27 to the Principal Order, delete the words "Articles 21(1) and 21(3)" and replace with the words "Articles 21(1), 21(3) and 21(6)(a)".
- 21. After Article 36 to the Principal Order, insert:-
