WARWICKSHIRE COUNTY COUNCIL

(DISTRICT OF STRATFORD ON AVON) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO. 2) (PART) ORDER 2006

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

- 1. The Warwickshire County Council (District of Stratford on Avon) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004, as varied by subsequent orders (which said Order of 2004 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
- 2. In Article 2 to the Principal Order, before the term "authorised agent" insert the terms:-
 - ""additional charge for parking" means the additional fee payable when applying to the Council for the suspension of a parking place in a pay & display area in accordance with Article 20 and being either ten pounds per day or forty pounds per week;
 - "administration fee" means the administration fee payable when applying to the Council for the suspension of a parking place in accordance with Article 20 of sixty pounds;"
- 3. In Article 2 to the Principal Order, before the term "penalty charge" insert the term:-
 - ""pay & display area" means a parking place identified upon the plans as pay & display and for which a specified charge for parking is payable;"
- 4. In Article 2 to the Principal Order, after the words:-
 - "specified charge for parking" means the fee payable for parking in a parking place" insert the words:-
 - "in a pay & display area"
- 5. At the beginning of Article 10(1) to the Principal Order, insert the words "Except in respect of a bus stop area,".
- 6. At the beginning of Article 11 to the Principal Order, insert the words "Except in respect of a bus stop area, ".

- 7. In Article 13(1) to the Principal Order, after the words "Provided the specified charge for parking" insert the words "in respect of a parking place within a pay & display area".
- 8. In Article 13(3) to the Principal Order, delete the words "to which this Order applies" and replace with the words "in a pay & display area".
- 9. In Article 13(3) to the Principal Order, after the words "payment is being made.", insert the words "Provided always that if the specified charge for parking is zero the driver of the vehicle obtains the appropriate ticket from the ticket machine relating to that parking place on the leaving of the vehicle in the parking place.
- 10. In Article 13(4) to the Principal Order, delete the words "The driver of the vehicle shall attach any ticket issued upon payment of the specified charge for parking" and replace with the words "The driver of any vehicle parking that vehicle in a parking place in a pay & display area, shall attach the ticket referred to in Article 13(3) above".
- 11. In Article 14(2) to the Principal Order, delete the words "shall not within the period specified in relation to that parking place and as identified on the plans after its leaving permit it to wait again upon that parking place" and replace with the words "shall not permit the vehicle to wait upon that parking place, or upon any other parking place in the same street, during the period specified on the plans in relation to the parking place".
- 12. In the Principal Order, delete Articles 19(1)(vi), 19(1)(vii) and 19(1)(x)
- 13. In the Principal Order, delete Article 20 and replace with:-
 - "20 (1) Any person authorised by the council may suspend the use of a parking place or any part thereof whenever he consider such suspension reasonably necessary for the purpose if facilitating the movement of traffic or promoting its safety.
 - (2) Any person may apply to the council for the suspension of a parking place or any part thereof for the purpose of:-
 - (a) for the purpose of any building operation, demolition or excavation in or adjacent to the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus, telephone kiosk or traffic sign;
 - (b) for the convenience of occupiers or premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
 - (c) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or

(d) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals, or any other special occasions.

Provided always the suspension of such a parking place shall be at the Council's discretion and any such application shall be made on a form obtainable from the Council and shall be submitted to the Council together with the administration fee and, if the application relates to a parking place in pay & display area, the additional charge for parking.

- (3) A police constable in uniform may suspend for not longer than twentyfour hours the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (4) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (1) paragraph (2) or paragraph (3) of this Article shall thereupon place or cause to be placed in or adjacent to that parking place or the part thereof the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited.
- (5) No person shall cause or permit a vehicle to be left in any parking place during such period as there is in or adjacent to that parking place a traffic sign placed in pursuance of paragraph (4) of this Article.

Provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for fire brigade, ambulance or police purposes or any vehicle being used for any purpose specified in Article 19(1)(ii), (iv) or (v) to be left in the parking place during any such period, or for any other vehicle so left if that vehicle is left with the permission of the persons suspending the use of the parking place or of a police constable in uniform or of a parking attendant."

- 14. In Article 21(6)(a) to the Principal Order, delete the words "shall specify whether the permit is required in respect of Zone S2, Zone S3, Zone S4 or Zone S8 (as detailed in the Schedule to this Order)".
- 15. In Article 22(1) to the Principal Order, after the words "first becomes valid." insert the words "Provided always that residents of a pensionable age and in receipt of housing or council tax benefits shall be entitled to a 50% reduction in the said charge in respect of the first permit issued to that resident."
- 16. In Article 32 to the Principal Order, after the words "in such positions" insert the words "on such days and during such hours".

17. In the Principal Order, after Schedule 1 insert:-

In the Principal Order, replace the sheets marked "Stratford on Avon District (West) Waiting Restrictions" and "Stratford on Avon District (East) Waiting Restrictions" with the sheets attached hereto and respectively marked "Stratford on Avon District (West) Waiting Restrictions Revision No. 1" and "Stratford on Avon District (East) Waiting Restrictions Revision No. 1"
- 21. In the Principal Order, replace the sheets marked "Stratford on Avon Restriction Types Page 1 of 2" and "Stratford on Avon Restriction Types Page 2 of 2" with the sheets attached hereto and respectively marked "Stratford on Avon Restriction Types Page 1 of 2 Revision No. 1" and "Stratford on Avon Restriction Types Page 2 of 2 Revision No. 2".
- 22. In the Principal Order, add the plan attached hereto and numbered S105A.
- 23. In the Principal Order, replace the plans listed in column 1 to the Schedule of this Order below with the plans listed in column 2 to the Schedule of this Order below and attached hereto.

24. This Order shall come into operation on the fifteenth day of May 2006 and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation (Variation No. 2) (Part) Order 2006"
