# (DISTRICT OF STRATFORD ON AVON) (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (WAITING RESTRICTIONS AND STREET PARKING PLACES) CONSOLIDATION (VARIATION NO. 5) (PART) ORDER 2007

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

- 1. The Warwickshire County Council (District of Stratford on Avon) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation Order 2004, as varied by subsequent orders (which said Order of 2004 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
- 2. In Article 12(a) to the Principal Order, after the words "Diagrams 668 and 668.2" insert the words "or Diagrams 667 and 667.2".
- 3. In the Principal Order, delete Article 13(3) and replace with:-
  - "(3) Save as provided in Articles 18 and 19 of this Order, the driver of any vehicle parking that vehicle in a parking place in a pay & display area, shall pay the specified charge for parking on the leaving of the vehicle in the parking place by the insertion in the ticket machine relating to that parking place of a coin or coins of the appropriate denomination making up the full amount of the specified charge for parking for the entire period in which the vehicle is to be left in that parking place. Provided always that if the specified charge for parking is zero the driver of the vehicle obtains the appropriate ticket from the ticket machine relating to that parking place on the leaving of the vehicle in the parking place."
- 4. In the Principal Order, after Article 13(5) insert:-
  - "13(6) The driver of a vehicle parking that vehicle in a parking place in a pay & display area shall not, after obtaining the ticket referred to in Article 13(3) above, insert in the ticket machine an additional coin or coins for the purpose of obtaining a further ticket for that vehicle in that parking place."
- 5. In the Principal Order, after Article 14(2), insert:-
  - "14A The driver of a vehicle shall not permit it to wait in a parking place provided for the parking of buses, which is comprised within and indicated by a road marking complying with diagram 1028.3 in Schedule 6 to the 2002 Regulations and incorporating the word "Buses" and indicated by a sign complying with diagram 661.1 of Schedule 2 to the 2002 Regulations, unless that vehicle is a bus."

- 6. In Article 18 to the Principal Order, after the number "14" insert the numbers "(1) and (2)".
- 7. In the Principal Order, delete Article 19(1)(xii) and replace with:-
  - "(xii) if the vehicle is being used by a home carer when visiting premises near to the parking place to provide care in the home for a resident, provided that the vehicle is left in a parking place identified on the plans as a parking place for residents permit holders and provided that a home carer's permit is displayed on the vehicle in the relevant position;"
- 8. In Article 19 to the Principal Order, after the words "and any such vehicle shall be exempt from any charge for parking" add the words "Provided always that the exemptions contained in this Article 19 shall not apply to a parking place described in Article 14A above."
- 9. In the Principal Order, after Article 21(6)(b), insert:-
  - "(6)(c) The Clerk to Stratford on Avon Town Council may apply to the Council for the issue of a Zone SM permit for the leaving of a motor car or motor cycle in the parking place in the lay-by on Sheep Street adjacent to the Town Hall.
  - (6)(d) On receipt of an application made under the foregoing provision of this Article, the Council may issue to the Clerk up to two permits for the leaving of any motor car or motor cycle in the parking place in Zone SM. Provided that there shall not be in force at any time more than two permits issued under the provisions of this Article."
- 10. In the Principal Order, after Article 23(3)(a)(iv) insert:-
  - "(v) the permit being used in such a manner which contravenes the provisions of this Order."
- 11. In the Principal Order, after Article 23(3)(b)(iii) insert:-
  - "(iv) the permit being used in such a manner which contravenes the provisions of this Order."
- 12. In the Principal Order, after Article 23(3)(c)(i) insert:-
  - "(ii) the permit being used in such a manner which contravenes the provisions of this Order."
- 13. In Schedule 1 to the Principal Order, after Zone S13, add:-

#### **"ZONE S14**

## ZONE SM Stratford Town Hall."

- 14. In the Principal Order, replace the Revision Sheet with the revision sheet attached hereto and marked "Revision Sheet No. 5".
- 15. In the Principal Order, replace the plans listed in column 1 to the Schedule of this Order below with the plans listed in column 2 to the Schedule of this Order below and attached hereto.
- 16. This Order shall come into operation on the Sixth day of August 2007 and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Permitted Parking Area and Special Parking Area) (Waiting Restrictions and Street Parking Places) Consolidation (Variation No. 5) (Part) Order 2007".
