**RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 8) (PART 1) ORDER 2010**

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

1. The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2008 as varied (which said Order of 2008 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.

2. In Schedule 1 to the Principal Order, in Zone S11 delete the words "Clopton Road – between Kendall Avenue and Vincent Avenue" and replace with:-

"Clopton Road – between Kendall Avenue and Vincent Avenue (excluding property numbers 55, 57, 59 and 61 Clopton Road)"

3. In Schedule 2 to the Principal Order, after the words:-

"Plan B"  
"HK37"  
"HN36"

replace the revision number "0" with the revision number "1".

4. In Schedule 2 to the Principal Order, after the words:-

"Plan A"  
"HL37"

replace the revision number "1" with the revision number "2".

5. In Schedule 2 to the Principal Order, after the words:-

"HM37"  
"HP37"

replace the revision number "2" with the revision number "3".

6. In Schedule 2 to the Principal Order, after the words:-

"Overall Plan"

replace the revision number "3" with the revision number "4".

7. In the Principal Order, replace the plans listed in column 1 to the Schedule of this Order below with the plans listed in column 2 to the Schedule of this Order below and attached hereto.

8. This Order shall come into operation on the Sixth day of April Two thousand and ten and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation No. 8) (Part 1) Order 2010".
