The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2008 as varied (which said Order of 2008 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
- 2. In Schedule 1 to the Principal Order, insert:-

Coventry Street (west side - residential properties between & including numbers 72 and 98a only)

Coventry Street (east side - residential properties between Wood Street & Meadow Road only)"

3. In Schedule 2 to the Principal Order, after the words:-

"GM80"
"GN80"
"GN81"
"GO80"
"HE15"

"HF15"; and

"IF64".

replace the revision number "0" with the revision number "1".

- 4. In Schedule 2 to the Principal Order, after the words "HP37" replace the revision number "3" with the revision number "4".
- 5. In Schedule 2 to the Principal Order, after the words "Overall Plan" replace the revision number "4" with the revision number "5".
- 6. In Schedule 2 to the Principal Order insert Plan Title "GQ79" Revision No. "0".

- 7. In the Principal Order, replace the plans listed in column 1 to the Schedule of this Order below with the plans listed in column 2 to the Schedule of this Order below and attached hereto.
- 8. In the Principal Order, add the plan attached hereto and numbered "GQ79 Revision No. 0".
- This Order shall come into operation on the Fourth day of October Two thousand and ten and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation No. 10) Order 2010".


