## **ROAD TRAFFIC REGULATION ACT 1984**

## THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 13) ORDER 2011

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

- 1. The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2008 as varied (which said Order of 2008 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
- 2. In Article 2 to the Principal Order, delete the definitions of "home carer" and "home carer's permit" and replace with the following definitions:-
  - ""home carer" means a person employed by a health authority, local authority or an approved private organisation to provide care or medical support in the home for a resident;
  - "home carer's permit" means a permit issued to a home carer under the provisions of Article 31;"
- 3. In Article 19(1)(viii) to the Principal Order, delete the words ", a health visitor or a midwife".
- 4. In the Principal Order, delete Article 19(1)(ix) and replace with:-
  - "(ix) if the vehicle is being used by a home carer when visiting premises near to the parking place to provide care or medical support in the home for a resident provided that a home carer's permit is displayed on the vehicle in the relevant position;"
- 5. In Article 31(2) to the Principal Order, after the words "provisions of" replace the words "paragraph (1) of this Article" with the words "either paragraph (1) or paragraph (2A) of this Article."

- 6. In the Principal Order, after Article 31(2) insert:-
  - Any resident within a permit controlled zone in possession of a motor car or motor cycle provided by his/her employer may apply to the Council for the issue of a permit for the leaving of such a vehicle in a parking place and any such application shall be made on a form issued by and obtainable from the Council and shall be accompanied by evidence from the applicant's employer that the vehicle provided will change frequently together with a remittance for such charge as provided by Article 32(1).
  - On receipt of an application made under the foregoing provision of this Article and the fee, the Council, upon being satisfied that the applicant is a resident and has the use of vehicles of the class specified in paragraph (1) of this Article, shall issue to that applicant one permit for the leaving of such a vehicle in any parking place within the zone to which such permit relates by the applicant or by any person using such vehicle with the consent of the applicant other than a person to whom such vehicle has been let for hire or reward. Provided that in respect of the residents of any one household there shall not be in force at any one time more than three permits issued under the provisions of either paragraph (1) or paragraph (2A) of this Article."
  - 7. In Article 32(1) to the Principal Order, after the words "Articles 31(1)" insert ", 31(2A)".
  - 8. In the Principal Order, after Article 31(5) insert:-
    - "(5A) A home carer who can justify the need for special parking arrangements close to a resident's home in order to provide care or medical support in the home to a resident may apply to the Council for the issue of a permit for the leaving of each vehicle specified in the application in a parking place and any such application shall be made on a form issued by and obtainable from the Council."
  - 9. In the Principal Order, after Article 31(6) insert:-
    - "(6A) Upon receipt of an application duly made under the foregoing provision (5A) of this Article the Council may issue to the applicant a home carer's permit for the leaving in the parking place specified thereon of such a vehicle specified in the application as they are satisfied are used by a home carer who has justified the need for special parking arrangements and to whom no suitable alternative parking facility is available."
  - 10. In Article 33(1) to the Principal Order, after the word "doctor" insert:-
    - ", paragraph 4(a) of this Article in respect of a permit issued to a home carer"

- 11. In the Principal Order, after Article 33(4) insert:-
  - "(4a) The events referred to in the foregoing provisions of this Article are, in respect of a permit issued to a home carer:-
    - (i) the vehicle or any vehicle in respect of which the permit was issued ceasing to be used by a home carer who can justify the need for special parking arrangements;
    - (ii) the issue of a revised permit or a duplicate permit by the Council under the provision of Article 34;
    - (iii) the permit being used in such a manner which contravenes the provisions of this Order."
- 12. In the Principal Order, after Article 36(1) insert:-
  - "(1A) in the case of a permit issued under the provisions of Article 31(2B) the words "Resident's Parking Permit";"
- 13. In Article 36(3) to the Principal Order, after the words "Article 31(6)" insert the words "or Article 31(6A)".
- 14. In Schedule 2 to the Principal Order, after the words:-

"GE11"

"GF10"

"GG10"

"GG11"

"GH11"

"HM41"

"HR38"

"HR39"

replace the revision number "0" with the revision number "1".

15. In Schedule 2 to the Principal Order, after the words:-

"GF11"

"HK37"

"HL41"

"HR35"


replace the revision number "1" with the revision number "2".

16. In Schedule 2 to the Principal Order, after the words

"FV27"

"HL37"

replace the revision number "2" with the revision number "3".

- 19. In the Principal Order, replace the plans listed in column 1 to the Schedule of this Order below with the plans listed in column 2 to the Schedule of this Order below and attached hereto.
- 20. In the Principal Order, add the plans attached hereto and numbered "HS38 Revision No. 0" and "HT38 Revision No. 0".
- 21. This Order shall come into operation on the Fourth day of July Two thousand and eleven and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation No. 13) Order 2011".
