**THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF STRATFORD ON AVON)
(CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING
PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 18)
ORDER 2013**

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the 1984 Act") the Traffic Management Act 2004 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with the Road Traffic Act 1991, hereby make the following Order:-

1. The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2008 as varied (which said Order of 2008 as varied is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.

2. In Article 31(10) to the Principal Order, delete:-

"(10) On receipt of an application made under the foregoing provision of this Article, the Council may issue to the Clerk up to two permits for the leaving of any motor car or motor cycle in the parking place in Zone SM. Provided that there shall not be in force at any time more than two permits issued under the provisions of this Article"

and replace with:-

"(10) On receipt of an application made under the foregoing provision of this Article, the Council may issue to the Clerk up to three permits for the leaving of any motor car or motor cycle in the parking place in Zone SM. Provided that there shall not be in force at any time more than three permits issued under the provisions of this Article"

3. In Schedule 2 to the Principal Order, after "FX27" replace the revision number "4" with the revision number "5".
4. In Schedule 2 to the Principal Order, after "HK37" replace the revision number "2" with the revision number "3".
5. In Schedule 2 to the Principal Order, after "HL37" replace the revision number "3" with the revision number "4".
6. In Schedule 2 to the Principal Order, after "HO37" replace the revision number "4" with the revision number "5".
7. In Schedule 2 to the Principal Order, after "HP36" replace the revision number "2" with the revision number "3".

8. In Schedule 2 to the Principal Order, after "HP37" replace the revision number "5" with the revision number "6".
9. In Schedule 2 to the Principal Order, after "HQ36" replace the revision number "1" with the revision number "2".
10. In Schedule 2 to the Principal Order, after "HQ37" replace the revision number "3" with the revision number "4".
11. In Schedule 2 to the Principal Order, after "JU48" replace the revision number "0" with the revision number "1".
12. In the Principal Order, replace the plans listed in column 1 of the Schedule to this Order below with the plans listed in column 2 of the Schedule to this Order below and attached hereto.
13. This Order shall come into operation on the Twenty-Second day of July Two thousand and thirteen and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation No.18) Order 2013".
