THE CITY OF SUNDERLAND (PERMITTED PARKING AREA AND SPECIAL PARKING AREA) (TRAFFIC ORDER AMENDMENTS) ORDER 2003

The Council of the City of Sunderland ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 45, 49, 51, 53 and 92 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and all other enabling powers after consultation with the Chief Constable of Northumbria Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into operation on 3rd February, 2003 and may be cited as "The City of Sunderland (Permitted Parking Area and Special Parking Area) (Traffic Order Amendments) Order 2003.

2. The Orders specified in Schedule 1 to this Order ("the Orders") are varied as follows:

(a) The following expressions and the meanings assigned to them are inserted in appropriate alphabetical order in that Article in the Orders which deals with the meanings of expressions used in the Orders:-

"Parking attendant" means a person authorised by or on behalf of the Council under Section 63A of the Act to supervise and enforce the restrictions imposed by this Order:

"Penalty charge" and "reduced penalty charge" means a charge set by the Council under the provisions of Section 74 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Sunderland) Order 2002 in accordance with guidance given by the Secretary of State for Transport which is to be paid in the manner described in the penalty charge notice within 28 days of the date of the notice or 14 days of the date of the notice in the case of a reduced penalty charge:

"Penalty charge notice" means a notice issued by a parking attendant pursuant to the provisions of Section 66 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Sunderland) Order 2002

(b) The expression "traffic warden" in that Article in the Orders which deals with the meanings of expressions used in the Orders is deleted.

(c) Each reference to traffic warden in the Orders is replaced by a reference to parking attendant.

(d) The Articles contained in Schedule 2 to this Order are inserted as the final Articles of the Orders.

3. Where a provision of this Order conflicts with a provision of any of the Orders specified in Schedule 1 to this Order or any other Order giving effect to parking controls, waiting or loading restrictions in car parks or roads within the administrative area of the Council of the City of Sunderland that provision of this Order shall prevail.

SCHEDULE 2

ARTICLES TO BE INSERTED INTO THE ORDERS SPECIFIED IN SCHEDULE 1 OR ANY OTHER ORDER GIVING EFFECT TO PARKING CONTROLS, WAITING OR LOADING RESTRICTIONS IN CAR PARKS OR ROADS WITHIN THE ADMINISTRATIVE AREA OF THE CITY OF SUNDERLAND

If a vehicle is left at any time in contravention of a provision of this Order a penalty charge shall be payable.

In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by Section 66 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Sunderland) Order 2002, may then be issued by a parking attendant in accordance with the requirements of Section 66 of that Act.
