

THE CITY OF SUNDERLAND (CIVIL ENFORCEMENT AREA)
(TRAFFIC ORDER AMENDMENTS) ORDER 2008

The Council of the City of Sunderland ("the Council") in exercise of its powers under Sections 1, 2, 3, 4, 19, 32, 35, 45, 49, 51, 53 and 92 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order shall come into force on 31st March, 2008 and may be cited as "The City of Sunderland (Civil Enforcement Area) (Traffic Order Amendments) Order 2008".
2. The Orders specified in Schedule 1 and Column 1 of Schedule 2 to this Order ("the Orders") are amended as follows:
 - (a) The following expressions and the meanings assigned to them are deleted (when included) in that Article in the Orders which deals with the meanings of expressions used in the Orders:-
 - (i) "parking attendant";
 - (ii) "penalty charge" and "reduced penalty charge" and
 - (iii) "penalty charge notice".
 - (b) The following expression and the meaning assigned to it is inserted in appropriate alphabetical order in that Article in the Orders which deals with the meanings of expressions used in the Orders:
 - (i) "civil enforcement officer" means a person authorised by or on behalf of the Council to supervise and enforce any restrictions imposed by this Order; and
 - (c) Each reference to parking attendant in the Orders other than any reference to parking attendant contained in any Article in the Orders which deals with the meanings of expressions used in the Orders is replaced by a reference to civil enforcement officer.
3. The Articles contained in Schedule 3 to this Order are deleted from each of the Orders specified in Part 1 of Schedule 1 to this Order.
4. The Articles contained in Schedule 3 to this Order are deleted (when included) from any other Orders giving effect to parking controls, waiting or loading restrictions in car parks or roads within the administrative area of the City of Sunderland.

5. The Orders specified in Column 1 of Schedule 2 to this Order are amended by the deletion of the Articles specified in Column 2 of that Schedule in relation to each such Order.
6. Where any provision of any of the Orders or of any other Order giving effect to parking controls, waiting or loading restrictions in car parks or roads within the administrative area of the Council conflicts with any provision of Part 6 of or Schedules 7, 8, 9, 10, 11 or 12 to the Traffic Management Act 2004 or of any Regulations made thereunder, the provision of the Traffic Management Act 2004 or the Regulations made thereunder shall prevail.
7. Where a provision of this Order conflicts with a provision of any of the Orders or any other Order giving effect to parking controls, waiting or loading restrictions in car parks or roads within the administrative area of the Council of the City of Sunderland that provision of this Order shall prevail.
8. The City of Sunderland (Permitted Parking Area and Special Parking Area) (Traffic Order Amendments) Order 2006 is hereby revoked.


SCHEDULE 3

ARTICLES TO BE DELETED FROM THE ORDERS SPECIFIED IN PART 1 OF SCHEDULE 1 AND ANY OTHER ORDER GIVING EFFECT TO PARKING CONTROLS, WAITING OR LOADING RESTRICTIONS IN CAR PARKS OR ROADS WITHIN THE ADMINISTRATIVE AREA OF THE CITY OF SUNDERLAND

1. If a vehicle is left at any time in contravention of a provision of this Order, other than a provision relating to a moving traffic offence, a penalty charge shall be payable.
2. In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by Section 66 of the Road Traffic Act 1991 as applied and modified by the Road Traffic (Permitted Parking Area and Special Parking Area) (City of Sunderland) Order 2002 may then be issued by a parking attendant in accordance with the requirements of Section 66 of that Act.
