THE CITY OF SUNDERLAND (PROHIBITION OF STOPPING BETWEEN 8.00 A.M. AND 5.00 P.M. MONDAY TO FRIDAY OUTSIDE VARIOUS SCHOOLS IN THE SOUTH SUNDERLAND AREA) TRAFFIC ORDER 2012

The Council of the City of Sunderland in exercise of its powers under Sections 1, 2 and 122 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other powers enabling it in that behalf and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, and with the persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996, hereby makes the following Order:-

1. This Order may be cited as "The City of Sunderland (Prohibition of Stopping Between 8.00 a.m. and 5.00 p.m. Monday to Friday Outside Various Schools in the South Sunderland Area) Traffic Order 2012 and shall come into force on 12th March 2012.

2. Definitions

- (1) In this Order:-
 - "civil enforcement officer" means a person authorised by or on behalf of the Council to supervise and enforce any restrictions imposed by this Order;
 - (b) "Keep Clear Area" means the part or parts of the carriageway of a road outside a school entrance identified by a road marking shown in diagram 1027.1 in Schedule 6 to the 2002 Regulations and described in Schedule 1 to this Order;
 - (c) "the 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002.
- (2) For the purposes of this Order a vehicle shall be taken to stop on a Keep Clear Area if:-
 - (a) any point in the Keep Clear Area is below the vehicle or its load (if any); and
 - (b) the vehicle is stationary.

3. Prohibition of Stopping

Subject to the exceptions set out in Article 4 of this Order no person shall cause or permit any vehicle to stop between the hours of 8.00 a.m. and 5.00 p.m. Monday to Friday (inclusive) on a Keep Clear Area.

4. Exceptions

Article 3 does not apply to:-

- a vehicle required to stop due to circumstances beyond the driver's control or in order to avoid injury or damage to any persons or property;
- (b) a vehicle being used for ambulance, fire brigade or police purposes if the observance of any provision of this Order would hinder the use of the vehicle for the purpose for which it is being used on that occasion;
- (c) a vehicle being used in connection with;
 - (i) any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of a road;
 - (iv) the laying, erection, alteration or repair of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus lawfully kept installed in or near a Keep Clear Area;
 - (v) the placing, maintenance or removal of any traffic sign;
 - (vi) the lawful direction of a police officer or civil enforcement officer in uniform; or
 - (vii) any statutory powers or duties of a local authority;
 - provided that in all the circumstances it is necessary to stop on the Keep Clear Area.
- (d) a vehicle used in the service of a Local Authority for the purpose of collecting refuse from premises adjacent to the Keep Clear Area.

REVOCATIONS

- The Orders specified in Column 1 of Schedule 2 to this Order are hereby revoked to the extent specified in Column 2 of Schedule 2 but in all other respects the said Orders shall continue to have full force and effect.
- If any existing Order or Orders whose provisions conflict with any of the
 provisions of this Order and the Schedules hereto has or have not been
 revoked by this Order or any other Order, then such conflicting Order or

Orders are hereby revoked to the extent that their provisions conflict with this Order.

SCHEDULE 1

Part or parts of the carriageway of a road where vehicles are prohibited from stopping between 8.00 a.m. and 5.00 p.m. Monday to Friday

Archer Road

- the south-east side from a point 4.7 metres north of its intersection with the extended south-western kerbline of Arbroath Road for a distance of 43.56 metres in a northerly direction;
- the south-east side from a point 61.36 metres north of its intersection with the extended south-western kerbline of Arbroath Road for a distance of 43.56 metres in a northerly direction;
- (iii) the south-east side from a point 121.42 metres north of its intersection with the extended south-western kerbline of Arbroath Road for a distance of 43.56 metres first in a northerly then in an easterly direction.

Ashbrooke Road

Balmoral Terrace

The north side from a point 45.6 metres east of its intersection with the extended north-eastern kerbline of Silksworth Road for a distance of 69.2 metres first in an easterly then in a southerly direction.

Blind Lane East Back

- the east side from a point 59.6 metres south from the extended southern kerbline of Tunstall View for a distance of 25.56 metres in a southerly direction;
- the east side from a point 160.5 metres south from the extended southern kerbline of Tunstall View for a distance of 37.56 metres in a southerly direction;
- the east side from a point 198.06 metres south from the extended southern kerbline of Tunstall View for a distance of 25.56 metres in a southerly direction;

(iv) the east side from a point 223.62 metres south from the extended southern kerbline of Tunstall View for a distance of 25.56 metres in a southerly direction.

Cambria Street

The south-east side from a point 45.3 metres from the intersection of the extended north eastern kerbline of Albion Street and the south-eastern kerbline of Cambria Street for a distance of 37.56 metres in an easterly direction.

Castle Green

- (i) the north-west side from its south-western extent for a distance of 31.56 metres in a north-easterly direction;
- (ii) the south-east side from its south-western extent in first a northeasterly direction then an easterly direction for a distance of 25.56 metres.

Charter Drive

The south side from a point 65.5 metres east from the extended eastern kerbline of Durham Road for a distance of 43.56 metres first in an easterly and then in a northerly direction.

Colchester Terrace

The east side from a point 14.4 metres from its intersection with the extended southern kerbline of Wycliffe Road for a distance of 43.56 metres in a southerly direction.

Corporation Road

The north-east side from a point 34 metres south-east from the extended south-eastern kerbline of Rosalie Terrace for a distance of 25.56 metres in a south-easterly direction.

Cortina Avenue

The west side from a point 23.1 metres south from the extended southern kerbline of Chester Road to a point 43.56 metres firstly in a southerly, then south easterly direction.

Fordfield Road

The north side from a point 35.2 metres west from the extended western kerbline of Front Road for a distance of 87.2 metres in a westerly direction.

Gleneagles Road

The south-west side from a point 32.2 metres south from the extended southern kerbline of Gartland Road for a distance of 43.56 metres in first a south-easterly then an easterly direction.

Gleneagles Square

The north-west side from a point 20.45 metres south from the extended south-western kerbline of Gleneagles Road for a distance of 43.56 metres in first a south-westerly then a westerly direction.

Grindon Lane

The north-east side from a point 79.7 metres north-west of the extended north western kerbline of Gleneagles Road, for a distance of 37.56 metres in a north-westerly direction.

Helvellyn Road

The north-west side from a point 54.1 metres north-east from the extended north-eastern kerbline of Leechmere Road for a distance of 87.2 metres in a north easterly direction.

Hurstwood Road

The south-east side from a point 27.8 metres south-west of the extended southern kerbline of Ranson Street for a distance of 51.22 metres in a south-westerly direction.

Hylton Road

The north-west side from a point 6.6 metres east of the intersection of the extended north-eastern kerbline of the eastern most access to Portsmouth Road with the north-western kerbline of Hylton Road, for a distance of 69.22 metres in a north-easterly direction.

Keelmans Lane

Ranson Street

The south side from a point 132.2 metres east from the intersection with the extended eastern kerbline of Hurstwood Road for a distance of 31.56 metres in an easterly direction.

Regal Road

The west side from a point 36.0 metres north from the intersection with the extended northern kerbline of Paxton Terrace for a distance of 25.6 metres in a northerly direction.

Richard Avenue

The north-east side from a point 35.3 metres north-west of its intersection with the extended north-western kerbline of Georgian Court and the north-eastern kerbline of Richard Avenue to its north-eastern extent.

Rosalie Terrace

- the south-east side from a point 18 metres north-east of its intersection with the extended north-eastern kerbline of Corporation Road for a distance of 31.56 metres in a north-easterly direction;

Rutland Street

 the east side from a point 26.9 metres north from the intersection of the extended northern kerbline of Well Street and the eastern kerbline of Rutland Street for a distance of 25.56 metres in a southerly direction; (ii) the east side from a point 29.8 metres south from the intersection of the extended southern kerbline of Well Street and the eastern kerbline of Rutland Street for a distance of 25.56 metres in a southerly direction.

Ryhope Road

The south-west side from a point 87.2 metres south-east from the intersection of the extended south-eastern kerbline of Matanzas Street and the south western kerbline of Ryhope Road for a distance of 81.2 metres in a south-easterly direction.

Saint Court

The south side from its western extent for a distance of 43.56 metres in an easterly direction.

Shaftesbury Avenue

The east side from a point 11.6 metres north of the extended northern building line of number 67 Shaftesbury Avenue with the eastern kerbline of Shaftesbury Avenue for a distance of 43.56 metres first in a southerly then in a south-westerly direction.

Shaftoe Road

- (i) the north-east side from a point 16.3 metres south-east of the intersection of the extended south-eastern kerbline of Silloth Road and the north-eastern kerbline of Shaftoe Road for a distance of 43.56 metres in a south-easterly direction;

The south-east side from a point 50.5 metres west from the intersection with the extended western kerbline of Commercial Road for a distance of 43.56 metres in a westerly direction.

Springwell Road

The east side from a point 2.6 metres north of its intersection with the extended southern kerbline of Broadstairs Court and the eastern kerbline of Springwell Road to a point 43.56 metres in a northerly direction.

Saint Lukes Road

- (i) the north-west side from a point 19.4 metres from the intersection of the extended south-western kerbline of Prestwick Road with the northwestern kerbline of Saint Lukes Road for a distance of 43.56 metres in a south-westerly direction;
- (ii) the north-west side from a point 121.8 metres from the intersection of the extended south-western kerbline of Prestwick Road with the northwestern kerbline of Saint Lukes Road for a distance of 37.56 metres in a south-westerly direction;
- (iii) the north-west side from its intersection with the extended southwestern kerbline of Keelmans Lane for a distance of 32 metres in a south-westerly direction.
