THE COUNCIL OF THE CITY OF SUNDERLAND ("the Council") in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53, and 122 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and with the persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

TITLE AND COMMENCEMENT

1. This Order may be cited as The City of Sunderland (Stadium of Light Area, Sunderland) (Waiting and Parking Places) (Amendment) Order 2016 and shall come into force on the 15th August 2016.

VARIATION

2. The City of Sunderland (Stadium of Light Area, Sunderland) (Waiting and Parking Places) Order 2014 is hereby varied by:-

(a) The deletion of the following definitions in alphabetical order in Article 2(1) :-

"Bus" "Bus Stop Clearway", "Passenger Vehicle" "School Keep Clear Area",
"The 2002 Regulations"

and the insertion of the following definitions

"Bus" has the same meaning as in Schedule 1 of the 2016 Regulations;

"Bus Stop Clearway" means the part or parts of the carriageway identified by a road marking shown in diagram 1025.1 in Schedule 7, Part 4 to the 2016 Regulations;

"Passenger Vehicle" means a vehicle constructed or adapted for the carriage of passengers and their effects;

"School Keep Clear Area" means the part or parts of a carriageway identified by a road marking shown in diagram 1027.1 in Schedule 7 Part 4 to the 2016 Regulations;

"The 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016";

(b) The insertion of the following items in alphabetical order in Schedule 1.01 No. Waiting at Any Time

Beaumont Street, Southwick, Sunderland

- (i) both sides from a point 5.9 metres west of its intersection with the extended party property boundary of 42 & 44 Goschen Street, to its western extent.

- (ii) the east side from a point 7.8 metres south of its intersection with the extended southern highway boundary of Ridley Street, for a distance of 28.4 metres in a northerly direction.
- (iii) the east side from a point 7.8 metres north of its intersection with the extended northern highway boundary of Goschen Street North Back, to a point 8.5 metres south of the extended southern highway boundary of Goschen Street.

Burntland Avenue, Southwick, Sunderland

the north side from a point 14.8 metres east of the intersection between its north-western highway boundary and the eastern highway boundary of Darwin Street East Back, to its eastern extent.

Coldstream Avenue, Southwick, Sunderland

both sides from a point 15.0 metres north-west of its intersection with the north-western highway boundary of Thompson Road, to its south-eastern extent.

Dean Terrace, Southwick, Sunderland

- (i) both sides from its intersection with the extended party property boundary of 20 & 22 Dean Terrace, to its eastern extent.
- (ii) the north side from a point 4.5 metres south-west of the intersection between its north-western highway boundary and the western highway boundary of Park Row, for a distance of 23.0 metres in a north-easterly direction.
- (iii) the north side from a point 2.2 metres south-west of the intersection between its north-western highway boundary and the western highway boundary of Freda Street East Back, for a distance of 13.1 metres in a north-easterly direction.
- (iv) the north side from a point 3.2 metres north-east of the intersection between its north-western highway boundary and the eastern highway boundary of Freda Street, to its western extent.

Goschen Street, Southwick, Sunderland

both sides from a point 10.5 metres west of the intersection between its southern kerbline and the western highway boundary of Thompson Road, to its eastern extent.

Northern Way, Southwick, Sunderland

the west side from a point 5.1 metres north of its intersection with the extended southern highway boundary of Dean Terrace South Back, for a distance of 45.0 metres in a northerly direction.

Ridley Street, Southwick, Sunderland

- (i) both sides from a point 4.2 metres east of its intersection with the eastern highway boundary of Beaumont Street, to its western extent.
- (ii) both sides from its intersection with the extended party property boundary of 4 & 6 Ridley Street, to its eastern extent.

The King's Road, Southwick, Sunderland

- (i) the north side from a point 3.5 metres west of the intersection between its northern kerbline and the extended eastern building line of 13-15 Beaumont Street, to its intersection with the centreline of Beaumont Street.
- (ii) the south side from a point 9.0 metres east of the intersection between its southern kerbline and the extended eastern building line of 13-15 Beaumont Street, to its intersection with the centreline of Beaumont Street.

Thompson Road

- (i) the north-west side from its intersection with the extended north-eastern property boundary of 2 Ridley Street, for a distance of 93.1 metres in a north-easterly direction.
- (ii) the north-west side from a point 9.2 metres north-east of the intersection between its north-western highway boundary and the northern highway boundary of Ridley Street, in a south-westerly direction for a distance of 31.0 metres.
- (iii) the west side from its intersection with the extended party property boundary of 02/104 & 106 Thompson Road, in a southerly direction for a distance of 26.3 metres.

Thompson Road South Back, Southwick, Sunderland

both sides from its intersection with the northern highway boundary of Southwick Road, for a distance of 6.6 metres in a northerly direction.
