THE CITY OF SUNDERLAND (HOUGHTON TOWN CENTRE) TRAFFIC ORDER 2019

THE COUNCIL OF THE CITY OF SUNDERLAND ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35 and 122 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and by virtue of the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and with the persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

TITLE AND COMMENCEMENT

1. This Order may be cited as The City of Sunderland (Houghton Town Centre) Traffic Order and shall come into force on the 5th August 2019.

DEFINITIONS

- 2.(1) In this Order:-

"Bay" means a space within a parking place which is provided for the leaving of a vehicle and indicated by markings on the surface of the parking place;

"Bus" has the same meaning as in regulation 2 of Schedule 1 of the 2016 Regulations;

"Bus Stop Clearway" means the part or parts of the carriageway identified by a road marking shown in diagram 1025.1 in Schedule 7 Part 4 to the 2016 Regulations;

"Carriageway" means a way constituting or comprised within a highway being a way (other than a cycle track) over which the public have a right of passage of vehicles but excludes any lay-by;

"Cycle" means a pedal cycle;

"Disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Driver" in relation to a vehicle waiting in a Parking Place, means the person driving the vehicle at the time it was left in the Parking Place;

"Goods Vehicle" means a motor vehicle or trailer constructed or adapted for use for the carriage or haulage of goods or burden of any description as in regulation 2 of Schedule 1 of the 2016 Regulations;

"Hackney Carriage" has the same meaning as in the Town Police Clauses Act 1847 and the Local Government (Miscellaneous Provisions) Act 1976;

"Hackney Carriage Rank" has the same meaning as in Section 63 of the Local Government (Miscellaneous Provisions Act) 1976;

"Invalid Carriage" has the same meaning as in Section 136 of the 1984 Act;

"loading bay" means a parking place for the purpose of loading and unloading and picking up and setting down of passengers;

"Motorcar" has the same meaning as in Section 136 of the 1984 Act;

"Motorcycle" has the same meaning as in Section 136 of the 1984 Act;

"parking disc" has the same meaning as in Regulation 8(5) of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000;

"parking place" means a place designated by this Order for the leaving of a vehicle;

"passenger vehicle" means a vehicle constructed or adapted for the carriage of passengers and their effects;

"pedal cycle" has the same meaning as in Regulation 2 of Schedule 1 of the 2016 Regulations;

"Public Body" means (i) Local Authority, or
(ii) NHS Trust or body; or
(iii) Statutory Undertaker or their agents;

"Regulated Road" means any of the roads, lengths of road sides of road or parts of road specified in the Schedules to this Order;

"Relevant position" means:-

(a) in the case of a disabled person's badge –

- (i) where a vehicle is fitted with a dashboard or fascia, the badge is exhibited on the dashboard or fascia, or
- (ii) where a vehicle is not fitted with a dashboard or fascia, the badge is exhibited in a conspicuous position on the vehicle

so that the front of the badge displaying the serial number and expiry date is clearly legible from the outside of the vehicle; and

(b) In the case of a parking disc –

- (i) where a vehicle is fitted with a dashboard or fascia the disc is exhibited on the dashboard or fascia; or
- (ii) where the vehicle is not fitted with a dashboard or fascia the disc is exhibited in a conspicuous position on the vehicle

so that, when marked to show the quarter hour period during which a period of waiting began, that period is clearly legible from the outside of the vehicle; and

(c) In the case of a waiver certificate –

- (i) where a vehicle is fitted with a dashboard or fascia, the waiver certificate is exhibited on the dashboard or fascia, or
- (ii) where a vehicle is not fitted with a dashboard or fascia the waiver certificate is exhibited in a conspicuous position on the vehicle

so that the front of the waiver certificate showing the vehicle registration number, and the location and period to which the waiver or dispensation applies is clearly legible from the outside of the vehicle;

"School Keep Clear Area" means the part or parts of a carriageway of a road identified by a road marking shown in diagram 1027.1 in Schedule 7 Part 4 to the 2016 Regulations;

"Security Vehicle" means a vehicle protected by armour plate designed and constructed or adapted specifically for the delivery of bullion, money, jewellery, documents or other goods or burden which, by reason of their nature or value, are likely to require protection from any criminal offence and such vehicle is liveried to indicate its purpose of a security vehicle;

"Telecommunications Apparatus" has the same meaning as in paragraph 1(1) of Schedule 2 to the Telecommunications Act 1984;

"The 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016;

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Act.

"Universal Service Provider" and "Provision Of A Universal Postal Service" have the same meanings as in the Postal Services Act 2000;

“vehicle” means any motor car, motor cycle and Invalid carriage having the same meaning respectively as in section 136 of the Road Traffic Regulation Act 1984 and any Goods Vehicle and any passenger vehicle;.

“Waiver Certificate” means a certificate issued by or on behalf of the Council permitting a specified vehicle to wait in specified circumstances on a length or lengths of road where the waiting of that vehicle would otherwise be restricted or prohibited by the provisions of this Order;

- 2.(2) Any reference in this Order to any enactment, regulation or other similar instrument shall be construed as a reference to the enactment, regulation or other similar instrument as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment, regulation or other similar instrument.
- 2.(3) The Schedules form part of this Order and will have the same force and effect as if expressly set out in the body of this Order and any reference to this Order will include the Schedules.
- 2.(4) The headings to the Articles of this Order will not affect its construction.
- 2.(5) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2.(6) In this Order, the masculine includes the feminine and vice versa.

PROHIBITION OF WAITING

3. No Waiting at Any Time

Save as provided in Articles 7, 8, 9 and 10 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait at any time in or on a Regulated Road specified in Schedule 1.01 of the Order.

4. No Waiting Monday to Saturday (inclusive) between the hours of 8.00am to 6.00pm

Save as provided in Articles 7, 8, 9 and 10 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait between the hours of 8.00am to 6.00pm Monday to Saturday (inclusive) in or on a Regulated Road specified in Schedule 1.41 of this Order.

5. No Waiting All Days between the hours of 8.00am to 6.00pm

Save as provided in Articles 7, 8, 9 and 10 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait between the hours of 8.00am to 6.00pm on any day in or on a Regulated Road specified in Schedule 1.11 of this Order.

6. No Waiting All Days between the hours of 10.00am to 4.00pm

Save as provided in Articles 7, 8, 9 and 10 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait between the hours of 10.00am to 4.00pm on any day in or on a Regulated Road specified in Schedule 1.49 of this Order.

7. Exemptions

Nothing in Articles 3, 4, 5 and 6 of this Order shall render it unlawful to cause or permit any vehicle to wait in or on the Regulated Roads referred to therein for so long as may be necessary to enable:-

- (a) the picking up and setting down of passengers;
- (b) the vehicle, if it cannot conveniently be used for such purpose in another road, to be used in connection with any of the following purposes, namely:-
 - (i) the removal of any obstruction to traffic;
 - (ii) the maintenance, improvement or reconstruction of a road;
 - (iii) the laying, erection, alteration or repair in or on land adjacent to the said regulated roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of telecommunications apparatus;
- (c) any vehicle authorised by the Council or being used by the Council, if it cannot conveniently be used for such purposes in another road, to be used in the service of a local authority or its contractors in pursuance of that authority's statutory powers or duties;
- (d) the vehicle, being a vehicle of a universal service provider, to be used in the provision of a universal postal service;
- (e) the loading onto or unloading from the vehicle of goods at any time provided that this paragraph shall not apply so as to exempt any person from any prohibition contained in Articles of this Order unless the vehicle is a vehicle of a universal service provider engaged in the provision of a universal postal service;

- (f) an official vehicle being used for a wedding or funeral, if it cannot conveniently be used for such purpose in another road, to wait at or near to any premises situated on or adjacent to the regulated road for as long as waiting by that vehicle is reasonably necessary in connection with a wedding or funeral;
 - (g) the vehicle to be used in an emergency for police, fire and rescue or ambulance purposes if the observance of the prohibition of waiting would be likely to hinder the use of that vehicle for the purpose for which it is being used on that occasion.
- 8. Nothing in Articles 3, 4, 5 and 6 shall prevent any person from causing or permitting a vehicle to wait in any of the regulated roads referred to therein if it is displaying in the relevant position a valid waiver certificate issued by the Council and the vehicle is waiting in accordance with the terms and conditions of the said certificate
- 9. Nothing in Articles 3, 4, 5 and 6 of this Order shall render it unlawful to cause or permit the following vehicles to wait in any of the Regulated Roads referred to therein:-
 - (i) a hackney carriage waiting at a duly authorised hackney carriage rank during the period of operation of the hackney carriage rank;
 - (ii) a vehicle waiting in a parking place duly authorised by this Order or any other Order made under the Act provided that the vehicle is parked in accordance with the provisions of the Order which so authorised the parking place.
- 10. Nothing in Articles 3, 4, 5 and 6 of this Order shall render it unlawful to cause or permit a vehicle which displays in the relevant position continuously throughout the period of waiting a valid disabled person's badge and a parking disc marked to show the quarter hour period during which the period of exempted waiting began, to wait in a Regulated Road specified in Schedules 1.01, 1.41, 1.11 and 1.49 of this Order for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same road on the same day) provided that the vehicle immediately before or after the act of waiting has been or is about to be driven or used by the person to whom the badge has been issued or as the case may be, used for the carrying of that person as a passenger; and provided that nothing in this paragraph shall apply so as to exempt a vehicle from any prohibition contained in the said Articles during any period when a prohibition of loading or unloading applies to the Regulated Road concerned or any part thereof.
- 11. The prohibition of stopping in school keep clear areas overrides any entitlement to wait as specified in Articles 3, 4, 5 and 6 of this Order.
- 12. No person shall cause or permit any vehicle to stop or wait in a bus stop clearway, except in the circumstances provided in Schedule 7, Part 6 of 2016 Regulations. For the avoidance of doubt, where a length of road is marked as a bus stop clearway the

specific exceptions to the restriction or prohibition of waiting provided by Articles 3, 4, 5 and 6 shall not apply.

PROHIBITION OF LOADING AND UNLOADING

13. No Loading/Unloading At Any Time

Save as provided in Articles 16 and 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait at any time for the purpose of loading to or unloading from the vehicle, in or on a Regulated Road specified in Schedule 2.01.

14. No Loading/Unloading All Days between hours of 10.00am and 4.00pm

Save as provided in Articles 16 and 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait on any day between the hours of 10.00am and 4.00pm for the purpose of loading to or unloading from the vehicle, in or on a Regulated Road specified in Schedule 2.47.

15. No Loading/Unloading between Monday to Saturday (inclusive) 8.30am to 9.30am and 4.00pm to 6.00pm

Save as provided in Articles 16 and 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to wait Monday to Saturday (inclusive) between 8.30am to 9.30am and 4.00pm to 6.00pm for the purpose of loading to or unloading from the vehicle, in or on a Regulated Road specified in Schedule 2.62.

16. Exemptions

Nothing in Articles 13, 14 and 15 of this Order shall render it unlawful to cause or permit a vehicle to wait in or on a regulated road referred to therein for so long as may be necessary to enable:-

- (a) the picking up and setting down of passengers;
- (b) the vehicle, if it cannot conveniently be used for such purpose in another road, to be used in connection with any of the following purposes, namely:-
 - (i) the removal of any obstruction to traffic;
 - (ii) the maintenance, improvement or reconstruction of a road;

- (iii) the laying, erection, alteration or repair in or on land adjacent to the said regulated roads of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity or of telecommunications apparatus;
 - (c) any vehicle authorised by the Council or being used by the Council, if it cannot conveniently be used for such purposes in another road, to be used in the service of a local authority or its contractors acting in pursuance of that authority's statutory powers or duties;
 - (d) the vehicle, being a vehicle of a universal service provider, to be used in the provision of a universal postal service;
 - (e) an official vehicle being used for a wedding or funeral, if it cannot conveniently be used for such purpose in another road, to wait at or near premises situated on or adjacent to the regulated road for as long as waiting by that vehicle is reasonably necessary in connection with a wedding or funeral;
 - (f) the vehicle to be used in an emergency for police, fire and rescue or ambulance purposes if the observance of the prohibition of loading and unloading would be likely to hinder the use of that vehicle for the purpose for which it is being used on that occasion.
17. Nothing in Articles 13, 14 and 15 of this Order shall prevent any person from causing or permitting a vehicle to wait or load or unload in any of the regulated roads referred to therein if it is displaying in the relevant position a valid waiver certificate issued by the Council and the vehicle is waiting or loading or unloading in accordance with the terms and conditions of the said certificate.

DISABLED PERSONS' PARKING PLACES

18(1). All Days, All Hours

Each of the regulated roads specified in Schedule 3.01 is authorised to be used, subject to the provisions of this Order, as a parking place for vehicles displaying a valid disabled person's badge, provided always that there is on display in the vehicle in the relevant position a valid disabled person's badge.

- 18(2). No person shall cause or permit any vehicle to wait in a parking place authorised by this Order to be used by a vehicle displaying a valid disabled person's badge unless there is displayed on that vehicle in the relevant position a valid disabled person's badge and provided that the vehicle immediately before or after the act of waiting has been or is about to be driven or used by the person to whom the badge has been issued or, as the case may be, the carrying of that person as a passenger.

GENERAL PARKING PLACES

19. Parking: All Days, All Hours

Each of the Regulated Roads specified in Schedule 4.01 is authorised to be used, subject to the provisions of this Order as a Parking Place on All Days and All Hours.

20. Parking: All Days, 6.00 p.m. – 8.00 a.m. 20 Minutes Maximum, No Return within 40 minutes

Save as provided in Article 22 of this Order, each of the Regulated Roads specified in Schedule 4.04 is authorised to be used, subject to the provisions of this Order as a Parking Place on All Days between the hours of 6.00 p.m. until 8.00 a.m. for a maximum waiting period of twenty minutes provided that no vehicle which has been taken away from a Parking Bay within a Parking Place referred to in the said Schedule shall until the expiration of forty minutes from the time it was taken away, be left again in that Parking Place.

21. Exemption for vehicles displaying a valid Disabled Person's Badge

A vehicle which displays in the relevant position continuously throughout the period of waiting a valid Disabled Person's Badge shall be exempt from compliance with any limitation of time during which a vehicle may be left in a parking place specified in Schedule 4.04 of this Order or any return period specified, provided that the vehicle immediately before or after the act of waiting has been or is about to be driven or used by the person to whom the badge has been issued or as the case may be, used for the carrying of that person as a passenger.

22. Exemption for vehicle displaying a Dispensation Certificate

Nothing in Article 20 of this Order shall prevent any person from causing or permitting a vehicle to wait in any of the Parking Places referred to therein if it is displaying, in the relevant position, a valid Dispensation Certificate issued by the Council and the vehicle is waiting in accordance with the terms and conditions of the said certificate.

GENERAL PROVISIONS RELATING TO PARKING PLACES

23. No person shall cause or permit a vehicle to wait in a Parking Place referred to in Articles 18, 19 and 20 above other than wholly within the limits of a Bay.

24. No person shall use a Parking Place referred to in Articles 18, 19 and 20 above so as to prevent access to any premises adjoining the road or the use of the road by other persons, or so as to be a nuisance.

25. The driver of a vehicle using a Parking Place referred to in Articles 18, 19 and 20 above shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the Parking Place.
26. No person shall use any Parking Place referred to in Articles 18, 19 and 20 above or any vehicle while it is in a Parking Place, in connection with the sale or offering or exposing for sale any goods to any person in or near the Parking Place or in connection with the selling or offering for hire of his skills or services without the written permission of the Council.
27. Subject to the proviso hereto, when a vehicle is left in a Parking Place referred to in Articles 18, 19 and 20 above in contravention of any of the provisions contained in this Order a person authorised in that behalf by the Council may remove the vehicle or arrange for it to be removed from that Parking Place provided that when a vehicle is waiting in a Parking Place in contravention of any provisions regarding the position in which a vehicle must be parked in a Parking Place, a person authorised in that behalf by the Council may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision.
28. Any person removing a vehicle or altering its position by virtue of Article 27 of this Order may do so by towing or driving the vehicle or in such other manner as they may think necessary and may take measures in relation to the vehicle as they may think necessary to enable them to remove it or alter its position, as the case may be.
29. Where a person authorised by the Council removes or makes arrangements for the removal of a vehicle from a Parking Place by virtue of Article 27 of this Order, they shall make such arrangements as may be reasonably necessary for the safe custody of the vehicle.
- 30(1) Any person duly authorised by the Council may suspend temporarily the use of a Parking Place referred to in Articles 18, 19 and 20 above or any part thereof whenever they consider such suspension reasonably necessary:-
 - (a) for the purpose of facilitating the movement of traffic or promoting its safety;
 - (b) for the purpose of any building operation, demolition or excavation in or adjacent to the Parking Place or the maintenance, improvement or reconstruction of the highway or the cleansing of gullies in or adjacent to the Parking Place, the laying, erection, alteration, removal or repair in or adjacent to the Parking Place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any Telecommunications Apparatus or the placing, maintenance or removal of any traffic sign;
 - (c) for the convenience of occupiers of premises adjacent to the Parking Place on any occasion of the removal of furniture to or from one office or dwelling-house

adjacent to the Parking Place from or to a depository, another office or dwelling-house;

- (d) on any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed; or
- (e) for the convenience of occupiers of premises adjacent to the Parking Place at times of weddings or funerals or other special occasions;
- (f) to facilitate the holding of an event either in the Parking Place (including any part thereof) or in a street adjacent to the Parking Place or to enable members of the public to watch an event.

30(2) A police officer in uniform may suspend the use of a Parking Place referred to in Articles 18, 19 and 20 above or any part thereof whenever he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety. Any such suspension shall not exceed 24 hours.

30(3) Any person suspending the use of a Parking Place referred to in Articles 18, 19 and 20 above or any part thereof in accordance with the provisions of paragraph (1) or paragraph (2) of this Article shall thereupon place or cause to be placed in or adjacent to that Parking Place or part thereof a sign indicating that parking by vehicles is prohibited and the extent (where relevant) of the Parking Place where there is such a prohibition.

30(4) No person shall cause or permit a vehicle to wait in a Parking Place referred to in Articles 18, 19 and 20 above or any part thereof during such period as the Council (or any person authorised on its behalf) or a police officer has suspended the Parking Place or part thereof and notice of such suspension on or near the Parking Place indicates that waiting or parking is prohibited.

PARKING PLACES FOR LOADING AND UNLOADING

31(1). All Days and All Hours

Save as provided in Article 31(2) of this Order, the Regulated Roads specified in Schedule 5.01 of this Order, are authorised to be used, subject to the provisions in this Order, as parking places for the loading and unloading of vehicles.

31(2). No person shall cause or permit a vehicle to wait in any parking place described in Schedule 5.01 unless it is engaged in loading and / or unloading or picking up and / or setting down of passengers and in any case no vehicle shall be permitted to wait for any longer than is necessary to carry out the aforementioned activities.

32(1). All Days 4.00 pm to 10.00 am

Save as provided in Article 32(2) of this Order, the Regulated Roads specified in Schedule 5.03 of this Order, are authorised to be used, subject to the provisions in this Order, as parking places for the loading and unloading of vehicles between 4.00 p.m. to 10.00 a.m. on any day.

32(2). No person shall cause or permit a vehicle to wait in any parking place described in Schedule 5.03 unless it is engaged in loading and / or unloading or picking up and / or setting down of passengers and in any case no vehicle shall be permitted to wait for any longer than is necessary to carry out the aforementioned activities.

33. Nothing in Articles 31(2) and 32(2) above shall render it unlawful for a vehicle which displays in the relevant position continuously throughout the period of waiting a disabled person's badge and a parking disc marked to show the quarter-hour period during which the period of exempted waiting began, to wait in the parking places referred to in Articles 31 and 32 above for a period not exceeding three hours (not being a period of waiting by the same vehicle in the same road on the same day) provided that the vehicle immediately before or after the act of waiting or parking has been or is about to be driven or used by the person to whom the badge has been issued or as the case may be, used for the carrying of a disabled person as a passenger.

34(1) Loading Bay All Days All Hours Goods Vehicles Only

Save as provided in Article 34(2) of this Order, the Regulated Roads specified in Schedule 5.91 of this Order, are authorised to be used, subject to the provisions in this Order, as parking places for the loading and unloading of goods vehicles only.

34(2) No person shall cause or permit a vehicle other than a goods vehicle to wait in any parking place described in Schedule 5.91 unless it is engaged in loading and / or unloading or picking up and / or setting down of passengers and in any case no vehicle other than a goods vehicle shall be permitted to wait for any longer than is necessary to carry out the aforementioned activities.

35(1) Loading Bay All Days 8.00 am until 6.00pm Goods Vehicles Only

Save as provided in Article 35(2) of this Order, the Regulated Roads specified in Schedule 5.92 of this Order, are authorised to be used, subject to the provisions in this Order, as parking places for the loading and unloading of goods vehicles only, on all days between 8.00am until 6.00pm.

35(2) No person shall cause or permit a vehicle other than a goods vehicle to wait in any parking place described in Schedule 5.92 unless it is engaged in loading and / or unloading or picking up and / or setting down of passengers and in any case no

vehicle other than a goods vehicle shall be permitted to wait for any longer than is necessary to carry out the aforementioned activities.

No Entry, Except Buses and Cycles

36. Save as provided in Article 37 no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle other than a bus or cycle proceeding in the lengths of road specified in Column 2 of Schedule 11.01 to this Order from the direction specified in Column 3 of the said Schedule.
37. Nothing in Article 36 of this Order shall apply to:-
- (a) any police, fire and rescue service or ambulance vehicle on emergency call or the driving of any mechanical road cleansing vehicle;
 - (b) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building or demolition operation in or adjacent to the lengths of road, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the lengths of road, or the laying, erection, alteration or maintenance in or adjacent to the lengths of road of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
 - (c) any vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers or duties.

Prohibition of Motor Vehicles, except buses at any time, 4.00pm to 10.00am except loading and access to off-street premises

38. Save as provided in Article 39 no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle, except a bus at any time, or a vehicle loading or unloading or accessing off-street premises between the hours of 4.00 pm to 10.00 am on any day, from proceeding in the roads specified in Column 2 of Schedule 11.02 to this Order in the direction specified in Column 3 of the said Schedule.
39. Nothing in Article 38 of this Order shall apply to:
- (a) any police, fire and rescue service or ambulance vehicle on emergency call or the driving of any mechanical road cleansing vehicle;

- (b) a vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building or demolition operation in or adjacent to the lengths of road, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the lengths of road, or the laying, erection, alteration or maintenance in or adjacent to the lengths of road of any sewer, main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984;
- (c) any vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in pursuance of statutory powers or duties;
- (d) any Security Vehicle requiring access only for the purposes of delivering to or from any premises situated on or adjacent to the roads specified in Column 2 of Schedule 11.02 to this Order.

One Way Restriction

- 40. Save as provided in Article 41 of this Order no person shall cause any vehicle to proceed on the lengths of road specified in Column 2 of Schedule 11.40 to this Order in a direction other than that specified in Column 3 of the said Schedule.
- 41. Nothing in Article 40 shall apply to the driving of any mechanical road cleansing vehicle or to any police, fire and rescue service or ambulance vehicle on emergency call.

WAIVER CERTIFICATES

- 42. The Council may issue a waiver certificate on receipt of an application and may impose charges, terms and conditions as appropriate.
- 43. A waiver certificate may be cancelled at any time at the sole discretion of the Council and shall thereupon immediately cease to be valid. Notification of such cancellation shall be in writing to the holder of the certificate and either delivered to him personally or sent to or left at any address that the Council believes to be that person's address and the certificate shall forthwith be surrendered to the Council

REVOCATION

- 44(1) The Orders specified in the Revocations Schedule to this Order are hereby revoked to the extent specified therein, together with any provisions of any other Order or Orders that have amended or modified the Orders to be revoked.
- 44(2) If any existing Order or Orders whose provisions conflict with any of the provisions of this Order and the Schedules hereto has or have not been revoked by this Order or any other Order then such conflicting Order or Orders are hereby revoked to the extent that their provisions conflict with this Order.

SUPPLEMENTARY PROVISION

45. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.
