THE COUNCIL OF THE CITY OF SUNDERLAND ("the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 53, and 122 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act and with the persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

TITLE AND COMMENCEMENT

 This Order may be cited as The City of Sunderland (Sunderland Royal Hospital Area) (Waiting and Loading and Parking Places) (Amendment) Order 2017 and shall come into force on the 11th September 2017.

VARIATION

- 2. The City of Sunderland (Sunderland Royal Hospital Area) (Waiting and Loading and Parking Places) Order 2014 is hereby varied by:-
- (a) The deletion of the following definitions in alphabetical order in Article 2(1):-

"Bus" "Bus Stop Clearway", "Passenger Vehicle" "School Keep Clear Area", "The 2002 Regulations"

and the insertion of the following definitions

"Bus" has the same meaning as in Schedule 1 of the 2016 Regulations;

"Bus Stop Clearway" means the part or parts of the carriageway identified by a road marking shown in diagram 1025.1 in Schedule 7, Part 4 to the 2016 Regulations;

"Passenger Vehicle" means a vehicle constructed or adapted for the carriage of passengers and their effects;

"School Keep Clear Area" means the part or parts of a carriageway identified by a road marking shown in diagram 1027.1 in Schedule 7 Part 4 to the 2016 Regulations;

"The 2016 Regulations" means the Traffic Signs Regulations and General Directions 2016";
