SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2(1) to (3) 4 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

1. THIS Order may be cited as "The Surrey County Council Hershams Controlled Parking Zone in the Borough of Elmbridge (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2014 (Amendment No. 7) Order 2019" and shall come into force on 21 October 2019\_\_\_\_\_

2. (1) In this Order "the Principal Order" means The Surrey County Council Hershams Controlled Parking Zone in the Borough of Elmbridge (Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2014\_\_\_\_\_
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order\_\_\_\_\_

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-

(i) The following words were added to Article 67 as a second proviso:-

"AND PROVIDED THAT where validation of the said resident's visitor parking permit

is required to be written such validation shall be completed in permanent pen”

(ii) For the Second Schedule to the Principal Order there was substituted the Second Schedule set out in the Schedule to this Order\_\_\_\_\_
