SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 14(1) 32 35 36 45 46 47 48 49 51 52 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

Citation and commencement

1 This Order may be cited as "The Surrey County Council (Various Roads in Epsom and Ewell) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No. 7) Order 2023" and shall come into operation on 01 April 2023

Interpretation

2 (1) In this Order the expression –

"enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment

"Principal Order" means each of the relevant Principal Orders listed in Article 3(A) Article 3(B) Article 3(C) Article 3(D) Article 3(E) Article 4 and Article 5

- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (3) Unless the context otherwise required any expression used in this Order which is also used in the specified Principal Order shall have the same meaning as in the said Principal Order

Amendment of the Principal Orders

- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order: -
 - (A) The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation of Free Street Parking Places and Revocation) Order 2018 shall have effect as though: -

- (4) For the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order
- (B) The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2018 shall have effect as though for the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order
- (C) The Surrey County Council (Various Roads in Epsom and Ewell) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2018 shall have effect as though: -
 - (1) For the words "a certificate" in the interpretation of "Waiver Certificate" in paragraph (1) of Article 2 there was substituted the words "a paper or virtual certificate"

(2) The following paragraph was added to Article 2 immediately following paragraph (5)

"(6) Where a virtual waiver certificate has been obtained as an alternative to a paper waiver certificate and remains valid, any requirements in this Order for the waiver certificate to be displayed on the vehicle to which it relates shall not apply"

- (4) For the phrase "the Borough Council" there was substituted by the phrase"the Council" in paragraph (2) of Article 15
- (5) For the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the First Schedule to this Order
- (E) The Surrey County Council (Various Roads in Epsom and Ewell) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2018 shall have effect as though –

"hand held device" is a device used by a civil enforcement officer which is updated from time to time with information from virtual parking transactions

"virtual parking permit" means a parking permit electronically issued by the Borough Council to a resident or carer or medical or community care personnel resident's visitor or business"

"virtual parking transaction" can be a virtual resident parking permit virtual resident visitor parking permit a virtual waiver certificate a virtual carers parking permit a virtual operational parking permit or a virtual business parking permit"

(2) For the words "a certificate" in the interpretation of "Waiver Certificate" in paragraph (1) of Article 2 there was substituted the words "a paper or virtual certificate"

- (3) For the words "the Borough Council" in the interpretation of "Carer's Parking Permit" in paragraph (1) of Article 2 there was substituted the words "the Council"

- (8) the words "or by electronic means in the case of a virtual business parking permit" was inserted in paragraph (2) of Article 38 immediately following the words "business premises"

- (10) the phrase "either (1) was inserted in Article 24 and Article 28 and paragraph (6) of Article 31 and Article 39 immediately after the word "shall"

"(2) be a virtual resident's parking permit"

(12) the following paragraph was added to Article 28 immediately following the existing paragraph –

"(2) be a virtual operational parking permit"
