SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) 4(2) 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1. THIS Order may be cited as "The Surrey County Council (Various Roads in the Borough of Reigate and Banstead) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) Order 2018 (Amendment No. 5) Order 2022" and shall come into operation on 1 November 2022______

Amendment of the Principal Orders

- THE residents' parking place may be used subject to the provisions of this
 Order for the leaving during the permitted hours of such vehicles only as display in the
 manner specified in Article 21 Article 25 Article 27 Article 27(e) and Article 27(i) (as
 applicable) a valid permit issued in respect of that vehicle
 PROVIDE THAT nothing in this Article shall apply to a disabled person's vehicle which
 displays in the relevant position a disabled person's badge issued by any local
 authority which may be left in the residents parking place free of charge and without
 time limit
- (vii) For paragraph (b) of Article 11B, paragraph (b) of Article 11C and paragraph (a) of 11D the phrase "Articles 21 25 27 or 27(e)" was substituted with "Articles 21 25 27 27(e) or 27(i)"
- (viii) The following sub-paragraph shall be inserted in paragraph (1) of Article 16 immediately following paragraph (b)
 - "(c) Any childcare parking permit shall be included in the calculation herein of a resident's entitlement to a resident's parking permit as though it was a resident's parking permit"

- (x) The phrase "or is displaying in the manner specified in Article 25 or paragraph (7) of Article 27 or Article 27(e) or Article 27(i) a valid permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority" was inserted in Article 21 immediately following the number "10"
- (xi) The phrase "or is displaying in the manner specified in Article 21 or paragraph (7) of Article 27 or Article 27(e) or Article 27(i) a valid permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a

disabled person's badge issued by any local authority" was inserted in Article 25 immediately following the number "10"

- (xii) The phrase "or is displaying in the manner specified in Article 21 or Article 25 or Article 27(e) or Article 27(i) a valid permit or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority" was inserted in paragraph (7) of Article 27 immediately following the number "10"
- (xiii) For Article 27(e) there was substituted the following similarly numbered Article "Display of Carer's Parking Permit
 - 27(e) AT all times during which a passenger vehicle or a goods vehicle which is being used for the purposes specified in paragraph (1) of Article 27(a) is left in a residents' only parking place or shared use parking place identified on the plans during the permitted hours a valid Carer's Parking Permit shall be displayed on the vehicle in respect of which it is to be used on the front or near-side of the vehicle so that all the particulars on the Carer's Parking Permit are readily visible from the front or near-side of the vehicle

 PROVIDED THAT no such parking permit need be so displayed if the vehicle is waiting in the residents parking place pursuant to the provisions of Article 10 or displays in accordance with Article 21 or Article 25 or Article 27 or Article 27(i) a valid permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority"
- (xiv) The words "or limited to two hours as the case may be" was inserted in paragraphs (1) and (3) of Article 23 immediately following the words "without time limit"
- (xv) For paragraph (4) of Article 23 there was substituted the following similarly numbered paragraph -
 - (4) Subject to the provisions contained in paragraph (3) of this Article the number of residents' visitors parking permits issued in respect of each separate place of abode shall not exceed one hundred and fifty in each calendar year and two hundred and fifty two-hour residents' visitors' parking permits in each calendar year

PROVIDED THAT this paragraph shall have effect subject to the proviso that in certain exceptional circumstances the number of residents' visitor's parking permits issued in respect of each separate place of abode may exceed one hundred and fifty in each calendar year and two hundred and fifty two-hour residents' visitors' parking permits with no upper limit on the number of such permits so issued provided that in each case the exceptional circumstances referred to above are met and/or fully complied with"

- (xvi) For paragraph (6) of Article 23 there was substituted the following similarly numbered paragraph
 - "(6) The fee referred to in paragraph (3) of this Article payable to the Council in respect of -
 - (a) a resident's visitor's parking permit shall be £2 for each such parking permit and that the resident's visitor's parking permit shall be valid for a period of one day only
 - (b) a two-hour resident's visitor's parking permit shall be £1 for each such parking permit and that the two-hour resident's visitor's parking permit shall be valid for a period of two hours only"

 - (b) who receives regular visits from another person for the purpose of childcare pursuant to a contract of employment

may apply to the Council for the issue of a childcare parking permit for the leaving in any residents' only or shared use parking place situated within the lengths of roads specified in the First Schedule and identified on any of the plans during the permitted hours of either a passenger vehicle or goods vehicle or motor cycle and belonging to or being used by a person visiting that resident at those premises to carry out childcare duties and any such application shall be made either electronically or on a form issued by and obtainable from the Council and shall include the particulars and information required to be supplied and the Council may in its absolute discretion issue a childcare parking permit to such resident

- (2) THE Council may at any time require an applicant for a childcare parking permit or a childcare parking permit holder to produce to an officer of that Council such evidence in respect of an application for a childcare parking permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any childcare parking permit issued by them to that person as they may reasonably call for to verify that the childcare parking permit is valid
- (3) UPON receipt of an application duly made under the foregoing provisions of this Article and upon being satisfied that the applicant is in need of such visits by a childcare provider who is or are either the owner of either a passenger vehicle or goods vehicle or a motor cycle or a person authorised to use such a vehicle by the owner thereof the Borough Council may in its absolute discretion issue to the applicant therefor one childcare parking permit for the leaving without time limit during the permitted hours in any residents' only parking place or shared use parking place situated within the lengths of roads specified in the First Schedule and identified on any of the plans of a vehicle belonging to or being used by a person visiting that resident in the course of their duties

PROVIDED THAT the childcare parking permit is only valid in respect of any resident's premises that are situated in the roads or parts of the roads specified and described in the First Schedule

(4) IN any respect not specifically mentioned in paragraphs (1), (2) and (3) of this Article and Articles 27(g) 27(h) and 27(i) the procedure validity and terms of use of a childcare parking permit shall be the same as the procedure validity and terms of use of a residents' parking permit and this paragraph shall be construed accordingly

27(g) The fee payable in respect of a childcare parking permit shall be as for a resident's parking permit as specified in the Third Schedule and the childcare permit shall be taken into account when making the calculation in accordance with the charges specified in the Third Schedule which subject to the provisions of this Order shall be valid for a period of twelve months

Form of childcare parking permit

Display of childcare parking permit

27(i) AT all times during which a passenger vehicle or a goods vehicle which is being used for the purposes specified in paragraph (1) of Article 27(f) is left in a residents' only or shared use parking place within the lengths of roads specified in the First Schedule and identified on the plans during the permitted hours a valid childcare parking permit shall be displayed on the vehicle in respect of which it is to be used on the front or near-side of the vehicle so that all the particulars on the childcare parking permit are readily visible from the front or near-side of the vehicle

PROVIDED THAT no such parking permit need be so displayed if the vehicle is waiting in that parking place pursuant to the provisions of Article 10 or is displaying in the manner specified in Article 21 or Article 25 or paragraph (7) of Article 27 or Article 27(e) a valid parking permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority"

- (x) The phrase "or is displaying in the manner specified in Article 40 or Article 46 or Article 46(e) or Article 46(i) a valid permit in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority" was inserted in Article 44 immediately following the number "28"
- (xi) The phrase "or is displaying in the manner specified in Article 40 or Article 44 or Article 46(e) or Article 46(i) a valid permit in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge

issued by any local authority" was inserted in paragraph (7) of Article 46 immediately following the number "28"

(xii) For Article 46(e) there was substituted the following similarly numbered Article -

"Display of Carer's Parking Permit

46(e) AT all times during which a passenger vehicle or a goods vehicle which is being used for the purposes specified in paragraph (1) of Article 46(a) is left in a residents' only parking place or shared use parking place identified on the plans during the permitted hours a valid Carer's Parking Permit shall be displayed on the vehicle in respect of which it is to be used on the front or near-side of the vehicle so that all the particulars on the Carer's Parking Permit are readily visible from the front or near-side of the vehicle

PROVIDED THAT no such parking permit need to be so displayed if the vehicle is waiting in that parking place pursuant to the provisions of Article 18 or Article 28 or is displaying in the manner specified in Article 40 or Article 44 or paragraph (7) of Article 46 or Article 46(i) a valid parking permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority"

- (xiii) The words "or limited to two hours as the case may be" was inserted in paragraphs (1) and (3) of Article 42 immediately following the words "without time limit"

any of the plans during the permitted hours of either a passenger vehicle or goods vehicle or motor cycle and belonging to or being used by a person visiting that resident at those premises to carry out childcare duties and any such application shall be made either electronically or on a form issued by and obtainable from the Council and shall include the particulars and information required to be supplied and the Council may in its absolute discretion issue a childcare parking permit to such resident

Fee to be paid in respect of a childcare parking permit

46(g) The fee payable in respect of a childcare parking permit shall be as for a resident's parking permit as specified in the Fourth Schedule and the childcare permit shall be taken into account when making the calculation in accordance with the

charges specified in the Fourth Schedule which subject to the provisions of this Order shall be valid for a period of twelve months

PROVIDED THAT no such parking permit need be so displayed if the vehicle is waiting in that parking place pursuant to the provisions of Article 18 or Article 28 or is displaying in the manner specified in Article 40 or Article 44 or paragraph (7) of Article 46 or Article 46(e) a valid parking permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority"

- (xxi) The Schedule to this Order was added to the Principal Order as the Fourth Schedule
- (3) The Surrey County Council Permit Holders On-Street Parking Place (Permit Zone) in the Borough of Reigate and Banstead Order 2015 shall have effect as though –

- (xi) The phrase "Article 19(qq)" was inserted in Article 19(bb) and Article 19(ff) and paragraph (7) of Article 19(hh) immediately following the number and letters "19(mm)"
- (xii) The phrase "Article 19(qq)" was inserted in Article 19(mm) immediately following the number and letters "19(hh)"
- (xiii) The words "or limited to two hours as the case may be" was inserted in paragraph (3) of Article 19(dd) immediately following the words "without time limit"

- (xiv) For paragraph (4) of Article 19(dd) there was substituted the following similarly numbered paragraph -
 - (4) Subject to the provisions contained in paragraph (3) of this Article the number of residents' visitors parking permits issued in respect of each separate place of abode shall not exceed one hundred and fifty in each calendar year and two hundred and fifty two-hour residents' visitors' parking permits in each calendar year

PROVIDED THAT this paragraph shall have effect subject to the proviso that in certain exceptional circumstances the number of residents' visitor's parking permits issued in respect of each separate place of abode may exceed one hundred and fifty in each calendar year and two hundred and fifty two-hour residents' visitors' parking permits with no upper limit on the number of such permits so issued provided that in each case the exceptional circumstances referred to above are met and/or fully complied with"

- (xv) For paragraph (6) of Article 19(dd) there was substituted the following similarly numbered paragraph
 - "(6) The fee referred to in paragraph (3) of this Article payable to the Council in respect of -
 - (c) a resident's visitor's parking permit shall be £2 for each such parking permit and that the resident's visitor's parking permit shall be valid for a period of one day only
 - (d) a two-hour resident's visitor's parking permit shall be £1 for each such parking permit and that the two-hour resident's visitor's parking permit shall be valid for a period of two hours only"

(xvi) The following paragraph was added to Article 19(ee) immediately following paragraph (v) –

- "(vi) and in the case of a two-hour resident's visitor's parking permit a space for the insertion of the time of the commencement of waiting by the said vehicle in the parking place"
- (xvii) The words "and in the case of a two-hour resident's visitor's parking permit the time of the commencement of waiting by the said vehicle in the parking place" were added to Article 19(gg) immediately following the words "to be used" in the last line
- (xviii) For Article 19(jj) including the shoulder heading there was substituted the following similarly numbered Article –

"No Charge in respect of a carer's parking permit

19(jj) NO charge shall be payable in respect of a carer's parking permit which subject to the provisions of this Order shall be valid for a period of twelve months"

- (xix) Article 19(kk) was omitted in its entirety
- (xx) The following Section was added immediately following Section IV

"SECTION V - CHILDCARE PARKING PERMITS

Application for and issue of a childcare parking permit

- 19(nn) (1) ANY person
 - (a) who is resident or ordinarily resident at any premises the postal address of which is in the roads and lengths of roads specified and described in column 2 of the First Schedule and
 - (b) who receives regular visits from another person for the purpose of childcare pursuant to a contract of employment

may apply to the Council for the issue of a childcare parking permit for the leaving in any residents' only parking place or shared use parking place situated within a length of road specified on column 3 of the table in the First Schedule and identified on any of the plans during the permitted hours of either a passenger vehicle or goods vehicle or motor cycle and belonging to or being used by a person visiting that resident at those premises to carry out childcare duties and any such application shall be made either electronically or on a form issued by and obtainable from the Borough Council and shall include the particulars and information required to be supplied and the Council may in its absolute discretion issue a childcare parking permit to such resident

- (2) THE Council may at any time require an applicant for a childcare parking permit or a childcare parking permit holder to produce to an officer of that Council such evidence in respect of an application for a childcare parking permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any childcare parking permit issued by them to that person as they may reasonably call for to verify that the childcare parking permit is valid
- (3) UPON receipt of an application duly made under the foregoing provisions of this Article and upon being satisfied that the applicant is in need of such visits by a childcare provider who is or are either the owner of either a passenger vehicle or goods vehicle or a motor cycle or a person authorised to use such a vehicle by the owner thereof the Council may in its absolute discretion issue to the applicant therefor one childcare parking permit for the leaving without time limit during the permitted hours in any residents' only parking place or shared use parking place situated within the lengths of roads within a length of road specified in column 3 of the table in the First Schedule

and identified on any of the plans of a vehicle belonging to or being used by a person visiting that resident in the course of their duties

PROVIDED THAT the childcare parking permit is only valid in respect of any resident's premises that are situated in the roads or parts of the roads specified and described in Column 2 of the table forming the First Schedule

(4) IN any respect not specifically mentioned in paragraphs (1), (2) and (3) of this Article and Articles 19(00) 19(pp) and 19(qq) the procedure validity and terms of use of a childcare parking permit shall be the same as the procedure validity and terms of use of a residents' parking permit and this paragraph shall be construed accordingly

Fee to be paid in respect of a childcare parking permit

19(00) The fee payable in respect of a childcare parking permit shall be as for a resident's parking permit as specified in the Fourth Schedule and the childcare permit shall be taken into account when making the calculation in accordance with the charges specified in the Fourth Schedule which subject to the provisions of this Order shall be valid for a period of twelve months

Form of childcare parking permit

19(pp) A childcare parking permit shall be in writing and shall include the following particulars –

- (f) a serial number identifiable in the office of issue
- (g) the word "CHILDCARE"
- (h) the period during which the childcare parking permit shall remain valid
- (i) an indication that the childcare parking permit has been issued by the Council
- the appropriate letter identifying the roads or lengths of roads in which the permit is valid or

Display of childcare parking permit

19(qq) AT all times during which a passenger vehicle or a goods vehicle which is being used for the purposes specified in paragraph (1) of Article 19(nn) is left in a residents' only parking place or shared use parking place within the lengths of roads within column 3 of the table in the First Schedule and identified on the plans during the permitted hours a valid childcare parking permit shall be displayed on the vehicle in respect of which it is to be used on the front or near-side of the vehicle so that all the particulars on the childcare parking permit are readily visible from the front or near-side of the vehicle

PROVIDED THAT no such parking permit need be so displayed if the vehicle is waiting in that

parking place pursuant to the provisions of Article 19(h) or Article 19(t) or is displaying in the manner specified in Article 19(bb) or Article 19(ff) or paragraph (7) of Article 19(hh) or Article 19(mm) a valid parking permit issued in respect of that vehicle or is a disabled person's vehicle which displays in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority"

(xxi) The First Schedule to this Order was added to the Principal Order as the Fourth Schedule
