# The Surrey County Council Various Roads in The Borough of Runnymede (Residents' On-Street Street Parking Places) Order 2016 (Amendment No. 6) Order 2022

SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

#### **Citation and commencement**

1 THIS Order may be cited as "The Surrey County Council Various Roads in the Borough of Runnymede (Residents' On-Street Parking Places) Order 2016 (Amendment No. 6) Order 2022" and shall come into operation on 19 April 2022

2 (1) In this Order "the Principal Order" means The Surrey County Council Various Roads in the Borough of Runnymede (Residents' On-Street Parking Places) Order 2016

(2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment

(3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment

(4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

#### Amendment of the Principal Order

**3** WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though -

(1) The following Part was added to the Arrangement of Articles immediately following Part III -

(4) The following interpretations were added to paragraph (1) of Article 2 in alphabetical sequence -

""business" means an organisation occupying non-residential premises which is liable for an individual Business Rate and which organisation uses such premises for business purposes only

"Business Parking Permit" means a Business Parking Permit issued by the Borough Council pursuant to the provisions of Article 31F "Business Parking Permit holder" means a person to whom a business parking permit has been issued

"business premises" has the same meaning as in Regulation 1 of Part II of Schedule 3 of The Town and Country Planning (Control of Advertisements) Regulations 1982 (S. I. 1982/666)

"business user" means a person who occupies business premises for business purposes the postal address of which is within the roads or lengths of roads specified in column 2 of the Fifth Schedule "dual use parking place" means an area on a highway designated as a parking place by this Order for the leaving only of such vehicles as are specified in Article 8B

"hand held device" is a device used by a civil enforcement officer which is updated from time to time with information from the telephone payment parking system

"location identification number" means the unique number assigned to each paid for parking place or certain parking bays within that parking place within a road where the telephone payment parking system is operational

"registered driver" means the driver of a vehicle who has prior to leaving his or her vehicle in a dual use parking place who has registered so many of his or her personal details with a service provider as that service provider may require to enable the telephone payment parking system to be activated in favour of the said driver "service charge" means any charge payable to the service provider in addition to the appropriate fee payable in accordance with the provisions of this Order for drivers of vehicles using the telephone payment parking system

"telephone payment parking system" means a system to facilitate and monitor the payment of parking charges (together with any service charge) using any telephone or internet enabled device via communication with the service provider in accordance with instructions indicated on signs located at each dual use parking place where the system is operational" (5) For the interpretation of the expressions "residents' parking place" and "valid permit" in paragraph (1) of Article 2 there were substituted the following interpretations –

"residents' parking place means the area of highway authorised to be used as a parking place for the leaving during the permitted hours of such vehicles as display in the manner specified in Article 25 or Article 29 or paragraph (7) of Article 31 or Article 31E or Article 31H (as applicable) a valid permit issued in respect of that vehicle "valid permit" means a resident's parking permit or a resident's visitor's parking permit or an operational permit or a carer's permit or a business permit as the case may be issued and used in accordance with the provisions of this Order"

- (6) For Article 3 there was substituted the following Article -
- "3. EACH area on a highway comprising: -

(i) the lengths of carriageway of the roads specified in Column 3 of the table in the First Schedule (other than those described as a zone) and identified on the plans as a residents' parking place and bounded on one side of that length by the edge of the carriageway and having a width throughout of not less than 1.8 metres and/or

(ii) the area of highway specified and described as a zone in column 3 of the table in the First Schedule to this Order and indicated on the plans as a residents' parking place

is hereby designated as a residents' parking place for use on such days and during such hours as identified on the plans"

(7) The phrase or in the manner specified in Article 31H (if applicable)" was inserted in Article 4 immediately following the phrase "Article 31E"

(8) The phrase "or Article 31H" was inserted in Article 6 Article 7 Article 8 Article 25 and Article 29 and paragraph (7) of Article 31 immediately following the phrase "Article 31E"

(9) The phrase "or Article 31H" was inserted in Article 31E immediately following the phrase "Article 31"

(10) The words "AND DUAL USE" were inserted in the heading to PART IV immediately following the words "SHARED USE"

(11) The following Part was added immediately following PART III -

#### "PART III(A)

#### **DESIGNATION OF DUAL USE PARKING PLACES**

#### **Designation of such parking places**

8A EACH area on a highway comprising the lengths of carriageway of the roads specified in Column 3 of the table forming the First Schedule and identified on the plans as a dual use parking place and unless otherwise so specified bounded on one side of that length by the edge of the carriageway and having a minimum width throughout of 1.8 metres is designated as a dual use parking place

#### Vehicles for which such parking places are designated

8B EACH dual use parking place may be used subject to the provisions of this Order for the leaving of such vehicles only as are passenger vehicles (8 seats or less) goods vehicles motorcycles or invalid carriages: -

(a) for which a registered driver has paid the relevant fee specified in the Fourth Schedule via the telephone payment parking system or
(b) without time limit during the permitted hours of such vehicles as display in the manner specified in Article 25 or in the manner specified in Article 29 or in the manner specified in paragraph (7) of Article 31 or in the manner specified in Article 31E or in the manner specified in Article 31H (if applicable) a valid parking permit issued in respect of that vehicle

#### Payment in connection with the use of such parking places

8C The charge for any vehicle left in a dual use parking place referred to in paragraph (a) of Article 8A shall be identified as having been paid by using the telephone payment parking system, an indication that payment has been made and the parking period for which payment has been made shall appear on the hand-held device

PROVIDED THAT nothing in this Article shall apply to any vehicle waiting

in a dual use parking place provided that that vehicle displays in the manner specified in Article 25 or Article 29 or paragraph (7) of Article 31 or Article 31E or Article 31H (if applicable) a valid parking permit issued in respect of that vehicle

#### Indications on hand-held device as evidence

8D WITHOUT prejudice to the provisions in this Article if at any time while a vehicle is left in a dual use parking place and no indication appears on a handheld device that payment of the parking charge has been made using the telephone payment parking system, or an indication that the parking period for which payment was made has expired, it shall be presumed, unless the contrary is proved, that either -

- the parking charge has not been duly paid in respect of that vehicle; or
- (b) the parking period for which payment was made has already expired

PROVIDED THAT nothing in this Article shall apply to any vehicle waiting in a dual use parking place provided that that vehicle displays in the manner specified in Article 25 or Article 29 or paragraph (7) of Article 31 or Article 31E or Article 31H (if applicable) a valid parking permit issued in respect of that vehicle

#### **Exemptions for Disabled Persons**

- 8E (1) NOTWITHSTANDING the provisions of Article 14 the following vehicles may be left during the permitted hours in a dual use parking place referred to in Article 8A and identified on the plans provided that the use of that parking place in which the vehicle is left has not been suspended and any such vehicle shall be exempt from payment of the initial charge or penalty charge specified in this Order and shall also be exempt from the requirement to display a valid parking permit:-
  - (a) an invalid carriage or
  - (b) a disabled person's vehicle displaying in the relevant position a disabled person's badge issued by any local authority

(2) A vehicle which is so exempted from the payment of the initial charge or the penalty charge shall stand in the said parking place in accordance with the provisions of Article 9 and wholly within the limits of that parking place

# Restriction on returning to park in such a parking place after the initial period

8F WHERE a vehicle is left during the permitted hours in a dual use parking place referred to in Article 8A and identified on the plans for the initial period for which payment has been made the driver or person in charge of the vehicle shall not cause or permit the vehicle to return to wait in the same parking place until the expiration of the time specified in the key to the plans from the time it was taken away from that parking place

PROVIDED THAT nothing in this Article shall apply to any vehicle waiting in a dual use parking place provided that that vehicle displays in the manner specified in Article 25 or Article 29 or paragraph (7) of Article 31 or Article 31E or Article 31H (if applicable) a valid parking permit issued in respect of that vehicle

#### Placing of traffic signs etc.

- 8G SUBJECT to the provisions of Article 19 the Council and/or its agents (if any) shall -
  - (a) place and maintain in or in the vicinity of each dual use parking place referred to in Article 8A and identified on the plans a traffic sign or traffic signs indicating that such parking place may be used during the permitted hours for the leaving only of such vehicles specified in Article 8B and
  - (b) place and maintain a traffic sign or traffic signs indicating that any dual use parking place may be used by vehicles making payment of the parking charge using the telephone payment parking system and the location identification number of such a parking place and parking bay"

(12) The words "or dual use parking place" were inserted in paragraphs (4) and (8) of Article 20 and Article 25 and paragraphs (1) and (3) and (8) of

Article 27 and Article 29 and paragraphs (3) and (7) of Article 31 and paragraphs (1) and (3) of Article 31A and Article 31E immediately following the words "shared use parking place"

(13) The following Part was inserted in PART V immediately following SECTION IV -

#### **"SECTION V**

#### **BUSINESS PARKING PERMITS**

#### Application for and issue of a Business Parking Permit

- 31F (1) Any business user who is the owner of a vehicle of the following class that is to say a passenger vehicle a goods vehicle a motor-cycle that is essential to the business user's business may apply to the Borough Council for the issue of a business parking permit in respect of that vehicle and any such application shall be made either electronically or on a form issued by and obtainable from the Borough Council and shall include the particulars and information required by such form to be supplied
  - (2) The Council may at any time require an applicant for a business parking permit or a business parking permit holder to produce to an officer of the council such evidence in respect of an application for a business parking permit made to them as they may reasonably call for to verify any particulars or information given to them or in respect of any business parking permit issued by them to as they may reasonably call for to verify that the business parking permit is valid
  - (3) On receipt of an application duly made under the foregoing provisions of this Article the Borough Council upon being satisfied that the applicant is a business user and is the owner of a vehicle of the class specified in paragraph (1) of this Article shall issue to the applicant therefor upon receipt of the fee of fifty pounds for the first permit or the fee of seventy-five pounds for any subsequent permit one Business Parking Permit and a protective cover for the display therein of that Business Parking

Permit the Business Parking Permit being for the leaving during the permitted hours in a parking space (where such parking space is provided) in a residents' only parking place or shared use parking place or dual-use parking place situated on any road or part of a road specified in column 3 of the table forming the Fifth Schedule and the postal address of the business premises occupied by the aforesaid business user being within the roads or parts of the roads specified in column 2 of the aforesaid table to which such business parking permit relates by the owner of such vehicle or by any person using such vehicle with the consent of the owner

PROVIDED THAT the Council shall not issue a business parking permit to any business user which would be valid during any period during which -

- (a) any two other business parking permits issued to that business user are or would be valid or
- (b) any residents' parking permit issued to that business user and relating to the vehicle in question is or would be valid

AND PROVIDED ALSO THAT officers of the Borough Council have the absolute discretion to permit the issue of extra business parking permits where it is considered special circumstances exist

- (4) It is hereby stated by the Council that -
  - (a) the issuing of a business parking permit to a business parking permit holder does not guarantee that any parking space within any parking place will be available for use by the business parking permit holder aforesaid during the permitted hours and
  - (b) the business parking permit remains at all times whilst it is issued to a business parking permit holder the property of the Council

#### Form of a Business Parking Permit

31G A business parking Permit shall be in writing and shall include the following particulars: -

- the registration mark of the vehicle in respect of which the business parking permit has been issued and
- (ii) the period during which subject to the provisions of paragraph (4) of article 311 the business parking permit shall remain valid and
- (iii) an indication that the business Parking Permit has been issued by the Borough Council
- (iv) the indicator specified in column 1 of the table in the Fifth Schedule

#### **Display of a Business Parking Permit**

31H AT all times during which a vehicle of a class specified in paragraph (1) of Article 31F is left in a residents' only or shared use parking place or dual-use parking place during the permitted hours a valid Business Parking Permit shall be displayed on the vehicle in respect of which it is to be used on the front or near-side of the vehicle so that all the particulars on the business parking permit are readily visible from the front or near-side of the vehicle or

PROVIDED THAT no such business parking permit is required if the vehicle is waiting in such a parking place pursuant to the provisions of Article 14 or is displaying in the manner specified in Article 25 or Article 29 or paragraph (7) of Article 31 or Article 31E a valid parking permit issued in respect of that vehicle or is a disabled person's vehicle which is displaying in the relevant position or in the prescribed manner a disabled person's badge issued by any local authority

#### Refund of fee paid in respect of a Business Parking Permit

- (1) a business parking permit holder who surrenders a business parking Permit to the Council before the business parking permit becomes valid shall be entitled to a refund of the fee paid in respect thereof
  - (2) a business parking permit holder who surrenders a business parking permit to the Council after the business parking permit has become valid shall be entitled to a refund of part of the fee paid in respect thereof calculated in accordance with the

provisions of the next following paragraph

(3) the part of the fee which is refundable under the provisions of the last foregoing paragraph shall be calculated as the sum of one-twelfth of the sum paid in respect thereof in respect of each complete month of the period specified thereon as the period during which it shall be valid which remains unexpired at the time when the business parking permit is surrendered to the Council"

(14) For the First Schedule to the Principal Order there was substituted the Schedule set out in the First Schedule to this Order

(15) for the Second Schedule to the Principal Order there was substituted the Schedule set out in the Second Schedule to this Order

(16) The Third Schedule to this Order was added as the Fourth Schedule to the Principal Order

(17) The Fourth Schedule to this Order was added as the Fifth Schedule to the Principal Order
