 - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment
 - (4) Unless the context otherwise requires any expression used in this
 Order which is also used in the Principal Order shall have the same
 meaning as in that Order
- WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though for the Second Schedule to the Principal Order there was substituted the Second Schedule set out in the Schedule to this Order
