### Citation and commencement

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Runnymede) (Prohibition of Stopping Outside Schools) (No. 1) Order 2004) (Amendment No.4) Order 2011" and shall come into operation on 9 May 2011

# Interpretation

- In this Order "the Principal Order" means The Surrey County Council (Various Roads in Runnymede) (Prohibition of Stopping Outside Schools) (No. 1) Order 2004
  - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
  - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment
  - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order
  - (5) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the Article or Schedule bearing that number in this Order

# **Amendment of the Principal Order**

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the

Principal Order shall have effect as though -

- (a) The item labelled "The Grange Community Infant School" in the Schedule to this Order was added to the First Schedule to the Principal Order immediately following the item labelled "Salesian School"
- (b) The item labelled "Marshfields CE Infants School" in the First Schedule to the Principal Order was re-labelled "Ottershaw C of E Infant School"
- (c) For the items labelled "St Cuthberts Catholic Primary School" and "St Jude's CE School" in the First Schedule to the Principal Order there were substituted the similarly labelled items in the Schedule to this Order
