SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) 2(1) to (3) and 4 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**Citation and commencement**

1 THIS Order may be cited as "The Surrey County Council ((Various Roads in Spelthorne) (Prohibition of Stopping Outside Schools) (No. 1) Order 2006) (Amendment No. 10) Order 2017" and shall come into operation on 2 September 2017

**Interpretation**

- (1) In this Order "the Principal Order" means The Surrey County Council (Various Roads in Spelthorne) (Prohibition of Stopping Outside Schools) (No.1) Order 2006
  - (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
  - (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
  - (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

**Amendment of the Principal Order**

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though: -

(i) the following expressions and the meanings assigned thereto were deleted from paragraph (1) of Article 2 –

“Community School” “Community Special School” “Voluntary Controlled School”  
“Voluntary Aided School” “Foundation School” “Foundation Special School” have the same meanings as in Section 20 of the Schools Standards and Framework Act 1998  
“School Day” has the same meaning as in Section 579 of the Education Act 1996”

(ii) In paragraph (1) of Article 2 there was added the following expression which shall have the meaning hereby assigned to it –

“School” has the same meaning as in the Education Act 1996”

(iii) for the First Schedule to the Principal Order there was substituted the Schedule set out in the First Schedule to this Order

(iv) for the Third Schedule to the Principal Order there was substituted the Schedule set out in the Second Schedule to this Order
