SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 AND 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**Citation and commencement**

1 THIS Order may be cited as "The Surrey County Council (Lammas Close (D6347) Staines in the Borough of Spelthorne (On-Street Parking Place) Order 2010) (Amendment No.2) Order 2012" and shall come into operation on 28 May 2012

**Interpretation**

2. (1) In this Order "the Principal Order" means The Surrey County Council Lammas Close (D6347) Staines in the Borough of Spelthorne (On-Street Parking Place) Order 2010
- (2) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

**Amendment of the Principal Order**

3. WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though: -

- (a) In paragraph 1 of Article 2 for the expression "resident" and the meaning

assigned thereto there was substituted the following: –

“resident” means a person whose usual place of abode is at premises specified and described in Second Part of The Schedule”

(b) In paragraph (a) of Article 22 for the words “not more than one” there were substituted the words “one or more”

(c) For sub-paragraph (1) (b) of Article 22 there was substituted the following sub-paragraph: -

“ (1) (b)The number of Residents’ Parking Permits which may be issued by the Council or Borough Council in respect of each separate usual place of abode shall be calculated as the sum of the number of vehicles registered to residents at that usual place of abode minus the total number of off-street parking spaces available to that usual place of abode

(d) Sub-paragraphs (c) and (e) of paragraph (1) of Article 22 shall be deleted in their entirety

(e) In sub-paragraph (d) of Article 22 for the phrase “sub-paragraphs (a) (b) or (c)” there was substituted the phrase “sub-paragraphs (a) and (b)”

(f) In Paragraph (4) of Article 28 for the word “thirty” there was substituted the number “120”

(g) For the Second Part of the First Schedule to the Principal Order there was substituted the Second Part contained in the Schedule to this Order
