SURREY COUNTY COUNCIL in exercise of their powers under Sections 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order: -

**Citation and commencement**

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Spelthorne) (Amendments to Residents' Parking Permits and Residents' Visitor's Parking Permits) Order 2011" and shall come into operation on 1 December 2011

**Interpretation**

- (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
  - (3) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order
  - (4) Any reference in this Order to a numbered Article or Schedule shall unless the context otherwise requires be construed as a reference to the Article or Schedule bearing that number in this Order

**Amendment of the Principal Orders**

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Surrey County Council (Various Roads in Spelthorne) (Residents' On-Street Parking Places) Order 2010 shall have effect as though -

- (i) in paragraph (6) of Article 17 for the words "thirty pounds in respect of each Residents' Parking permit" there were substituted the words "fifty pounds for the first permit and seventy-five pounds for any subsequent permit"
- (ii) for the paragraph numbered (5) in Article 19 there was substituted the similarly numbered paragraph below  
 "(5) The charge for the issue of a duplicate parking permit shall be fifteen pounds for each duplicate parking permit issued pursuant to paragraph (1) or paragraph (2) of this Article
- (iii) There was added as Article 17A the following Article -  

**"Application for the Re-issue of a Residents Parking Permit upon a change of vehicle with a different registration mark**

17A WHERE a resident or a parking permit holder applies for the issue of a further parking permit due to that resident or that parking permit holder changing the vehicle in respect of which the original parking permit was issued so that the original parking permit no longer bears the registration mark of the vehicle in respect of which that original parking permit was first issued under the provisions of Article 17 (1) then the original parking permit shall be surrendered to the Council and immediately a further parking permit will be issued bearing the registration mark of the new vehicle PROVIDED THAT there shall then be payable to the Borough Council a sum of fifteen pounds for the issue of that further parking permit which shall be valid for the remainder of the period stated on the original parking permit under the provisions of Article 20 (b)"
- (iv) In Article 2 the following expression and meaning assigned to it was added: -  
 "registration mark" has the same meaning as in Section 31 of the Vehicles (Crime) Act 2001"
- (v) In paragraph (2) of Article 18 for the words "paragraph 3(a) (b) (d) (e) or (f)" there was substituted the words "3 (a) (d) (e) or (f)"
- (vi) Sub paragraph (b) of paragraph (3) of Article 18 were deleted in its entirety
- (vii) In paragraph (6) of Article 23 for the words "one pound" there were substituted the words "two pounds"

4        WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Surrey County Council Lammas Close (D6347) Staines in the Borough of Spelthorne (On-Street Parking Place) Order 2010 shall have effect as though -

- (i)        in paragraph (7) of Article 22 for the words "thirty pounds in respect of a Parking permit" there were substituted the words "fifty pounds for the first permit and seventy-five pounds for any subsequent permit"
- (ii)        The paragraph numbered (4) below was added to Article 24 as the similarly numbered paragraph  
            "(4) The charge for the issue of a duplicate parking permit shall be fifteen pounds for each duplicate parking permit issued pursuant to paragraph (1) or paragraph (2) of this Article"

- (iii)        There was added as Article 22A the following Article -

**"Application for the Re-issue of a Residents Parking Permit upon a change of vehicle with a different registration mark**

22A WHERE a resident or a parking permit holder applies for the issue of a further parking permit due to that resident or that parking permit holder changing the vehicle in respect of which the original parking permit was issued so that the original parking permit no longer bears the registration mark of the vehicle in respect of which that original parking permit was first issued under the provisions of Article 22 (1) then the original parking permit shall be surrendered to Council and immediately a further parking permit will be issued bearing the registration mark of the new vehicle PROVIDED THAT there shall then be payable to the Borough Council a sum of fifteen pounds for the issue of that further parking permit which shall be valid for the remainder of the period stated on the original parking permit under the provisions of Article 25 (b)"

- (iv)        In Article 2 the following expression and meaning assigned to it was added: -  
            "registration mark" has the same meaning as in Section 31 of the Vehicles (Crime) Act 2001"
- (v)        In paragraph (2) of Article 23 for the words "paragraph 3(a) (b) (d) (e) or (f)" the re was substituted the words "3 (a) (d) (e) or (f)"
- (vi)        Sub paragraph (b) of paragraph (3) of Article 23 were deleted in its entirety

- (viii) In paragraph (6) of Article 28 for the words "one pound" there were substituted the words "two pounds"
