Citation and commencement

1 THIS Order may be cited as "The Surrey County Council ((Service Area No. 3 off Park Street Camberley in the Borough of Surrey Heath) (On-Street Business Parking Places) (No. 1) Order 2008) (Amendment No. 2) Order 2009" and shall come into operation on 2 February 2009

Interpretation

2 (1) In this Order "the Order of 2008" means The Surrey County Council (Service Area No. 3 off Park Street Camberley in the Borough of Surrey Heath) (On-Street Business Parking Places) Order 2008

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment

(3) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2008 shall have the same meaning as in that Order

Amendment of the Order of 2008

2008 shall have effect as though in paragraph (8) of Article 17 in the second line thereof for the words "one thousand and one hundred and ninety pounds" there were substituted the words "one thousand and two hundred and fifty pounds" \_\_\_\_\_
