(AMENDMENT NO.3) ORDER 2009**

SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2(1) to (3) and 4 and 32 35 36 45 and 46 of and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council Camberley Controlled Parking Zone in the Borough of Surrey Heath (Consolidation of Waiting and Loading and Unloading Restrictions and On-Street Parking Places) Order 2006 (Amendment No.3) Order 2009" and shall come into operation on 2 February 2009

Interpretation

- 2 (1) In this Order "the Principal Order" means "The Surrey County Council Camberley Controlled Parking Zone in the Borough of Surrey Heath (Consolidation of Waiting and Loading and Unloading Restrictions and On-Street Parking Places) Order 2006"
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

Amendment of The Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as though:-

- (a) For Article 46 (1) in the Principal Order there was substituted the following similarly numbered Article –

“46 (1) Any resident who is the owner of a vehicle of the following class that is to say a passenger vehicle a goods vehicle a motor cycle or an invalid carriage whose usual place of abode has no off street parking and/or garage facilities may apply to the Council for the issue to him of a residents’ parking permit in respect of that vehicle

PROVIDED THAT only one residents’ parking permit may be issued by the Council in respect of each separate usual place of abode”

- (b) For Article 51 in the Principal Order there was substituted the following similarly numbered Article –

“51 (1) A residents parking permit holder who surrenders a residents parking permit to the Council before the residents parking permit becomes valid shall be entitled to a refund of the fee paid in respect thereof

(2) A residents parking permit holder who surrenders a residents parking permit to the Council after the residents parking permit has become valid shall be entitled to a refund of part of the charge paid in respect thereof calculated in accordance with the provisions of the next paragraph

(3) The part of the charge which is refundable under the provisions of the last foregoing paragraph shall be calculated as one-twelfth of the sum paid in respect thereof in respect of each complete month of the period specified thereon as the period during which it shall be valid which remains unexpired at the time when the permit is surrendered to the Council”

- (c) For Article 55 in the Principal Order there was substituted the following similarly numbered Article –

“55 (1) A business parking permit holder who surrenders

a business parking permit to the Council before the business parking permit becomes valid shall be entitled to a refund of the fee paid in respect thereof

(2) A business parking permit holder who surrenders a business parking permit to the Council after the business parking permit has become valid shall be entitled to a refund of part of the charge paid in respect thereof calculated in accordance with the provisions of the next paragraph

(3) The part of the charge which is refundable under the provisions of the last foregoing paragraph shall be calculated as one-twelfth of the sum paid in respect thereof in respect of each complete month of the period specified thereon as the period during which it shall be valid which remains unexpired at the time when the permit is surrendered to the Council”

- (d) For Article 46 (6) in the Principal Order there was substituted the following similarly numbered Article –

“46 (6) The fee referred to in paragraph (1) of this Article payable to the Council shall be in accordance with the table below the sum of eighteen pounds in respect of a Residents’ Parking Permit which subject to the provisions of this Order shall be valid for a period of twelve months running from any day of the month on which the parking permit first becomes valid (this sum will be reduced by one-twelfth per month for periods of less than twelve months)”

- (e) For Article 52 (3) in the Principal Order there was substituted the following similarly numbered Article –

“52 (3) On receipt of an application duly made under the foregoing provisions of this Article the Council upon being satisfied that the applicant is a business user and is the owner of a vehicle of the class specified in paragraph (1) of this Article shall issue to the applicant therefor upon receipt of the fee of one thousand two hundred and fifty pounds one business permit

or a proportionate part thereof and shall be valid for a period commencing from the beginning of the month from which the permit first becomes valid to the following 31<sup>st</sup> March for the display therein of that business permit the business permit being for the leaving during the permitted hours in a parking space situate on any road or part of a road specified in Column 3 of the table forming Schedule 1 part 2 to this Order the postal address of the business premises occupied by the aforesaid business user by the owner of such vehicle or by any person using such vehicle with the consent of the owner:

PROVIDED THAT the Council shall not issue a business permit to any business user which would be valid during any period during which any resident's permit issued to that business user and relating to the vehicle in question is or would be valid

AND PROVED ALSO THAT officers of the Council have the absolute discretion to permit the issue of extra business permits where it is considered special circumstances exist"

- (f) in the Second Schedule to the Principal Order for the plan numbered 3282/SYH/1300 in the Principal Order there was substituted the plan numbered 3282/SYH/1300C annexed to this Order
- (g) For the Second Schedule to the Principal Order there was substituted the Second Schedule set out in THE SCHEDULE to this Order
