THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1 (1) and 2 (1) to (3) and 4(2) and 32 35 36 45 and 46 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

THIS Order may be cited as "The Surrey County Council (Camberley Controlled Parking Zone in the Borough of Surrey Heath) (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2006) (Amendment No. 2) Order 2008" and shall come into operation on 23 June 2008

Interpretation

- 2 (1) In this Order "the Order of 2006" means The Surrey County Council (Camberley Controlled Parking Zone in the Borough of Surrey Heath) (Consolidation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2006
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (3) Unless the context otherwise requires any expression used in this Order which is also used in the Order of 2006 shall have the same meaning as in that Order

Amendment of the Order of 2006

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Order of

2006 shall have effect as though:-

- (a) in PART III SECTION I of the ARRANGEMENT OF ARTICLES for the words "SECTION I - DESIGNATION OF FREE PARKING PLACES" there were substituted the words "SECTION I - DESIGNATION OF SHARED USE PARKING PLACES"
- (b) in PART III of the ARRANGEMENT OF ARTICLES for the words "SECTION II -DESIGNATION OF DISABLED PERSONS' FREE PARKING PLACES" there were substituted the words "SECTION II - PARTS OF ROADS AUTHORISED TO BE USED AS DISABLED PERSONS' FREE PARKING PLACES"
 - (c) in SECTION II of PART III of the ARRANGEMENT OF ARTICLES for the words "Designation of such parking places" and "Vehicles for which such parking places are designated" there were substituted respectively the words "Authorisation of such parking places" and "Vehicles for which such parking places are authorised to be used"
- (d) in paragraph (1) of Article 2 the expression "free parking place" and the meaning assigned thereto was deleted in its entirety
- (e) in paragraph (1) of Article 2 there were added the following expressions -
 - " "business parking place" means an area on a highway designated as a parking place by this Order for the leaving during the permitted hours of such vehicles as display in the manner specified in Article 54 a valid business permit issued in respect of that vehicle

"bus stop clearway" has the same meaning as in sub-paragraph (a) of paragraph 1 of Schedule 19 to the Traffic Signs Regulations and General Directions 2002 (S.I. 2002 No. 3113)

"shared use parking place" means an area on a highway designated as a parking place by this Order for the leaving free of charge of such vehicles only as are passenger vehicles goods vehicle motor cycles and invalid carriages by virtue of the provision of paragraph (a) of Article 11 and/or for the leaving with a charge during the permitted hours of such vehicles as display in the manner specified in Article 50 a valid residents permit in respect of that vehicle and/or for the leaving without

- charge during the permitted hours of such vehicles as display in the manner specified in Article 50 and paragraph (4) of Article 56 a valid operational parking permit in respect of that vehicle"
- (f) in paragraph (1) of Article 2 for the expression "parking place" and the meaning assigned thereto there was substituted respectively the following expression and meaning assigned thereto -
 - " "parking place " means -
 - (a) any area on a highway designated as a street parking place by this Order or
 - (b) any part of a road authorised by this Order to be used as a street parking place"
- (g) in PART III SECTION I DESIGNATION OF FREE PARKING PLACES for the words "free parking places" or "free parking place" wherever those words occur there were substituted respectively the words "shared use parking places" or "shared use parking place"
- (h) for Article 20 there was substituted the following similarly numbered Article -"Authorisation of such parking places
 - EACH part of a highway comprising the length of carriageway of a road identified by the key relating to the plans as a disabled persons' parking place within the area shown marked by a black broken line and labelled as Camberley Controlled Parking Zone on any of the plans and unless otherwise identified on the plans bounded on one side of that length by the edge of the carriageway and having a width throughout of 2.7 metres is authorised to be used subject to the following provisions of this Section as a disabled person' parking place for use on such days and during the hours as identified on the key relating to the aforesaid key relating to the plans"
- (i) in Article 21 in the shoulder heading thereto for the words "are designated" there were substituted the words "are authorised to be used"
- (j) in paragraph (3) of Article 52 after the words "AND PROVIDED ALSO THAT officers of the Council have absolute discretion to permit the issue of extra business permits

where it is considered special circumstances exist" there were added the words "AND FURTHER PROVIDED ALSO THAT no business permit shall be issued under the provisions of this Order which relates to a business parking place designated in Service Area No. 3 or any part and/or parts thereof by The Surrey County Council (Service Area No. 3 off Park Street Camberley in the Borough of Surrey Heath) (On-Street Business Parking Places) (No. 1) Order 2008"

- (k) in paragraph (d) of Article 53 for the words "the Service Area to which the business permit relates" there were substituted the words "the Service Area (excluding Service Area No. 3) to which the business permit relates"
- (I) in paragraph (3) of Article 56 the eighth and ninth lines thereof for the words "(a) in any free parking place or (b) in any residents' parking place" there were substituted the words "in any shared use parking place"
- (m) in column 2 of Part I of the First Schedule for the words "Park Street" there were substituted respectively the words "That length of Park Street lying north of Pembroke Broadway" and the words "That length of Park Street lying south of Pembroke Broadway"
- (n) in column 3 of Part I of the First Schedule -
 - (i) for the words "High Street" there were substituted the words "High Street and St Georges Road"
 - (ii) the words "Park Street" were deleted from that column of that Part of that Schedule
 - (iii) opposite the entry in Column 2 of that Part of that Schedule relating to "That length of Park Street lying to the north of Pembroke Broadway" there were added to the said Column 3 of the said Part of the said Schedule the words "Service Road adjacent to A30 London Road"
 - (iv) opposite the entry in Column 2 of that Part of that Schedule relating to "That length of Park Street lying to the south of Pembroke Broadway" there were added to the said Column 3 of the said Part of the said Schedule the words "Middle Gordon Road"

- (v) for the words "Obelisk Way" there were substituted the words "Service Road adjacent to A30 London Road"
- (vi) for the words "Grace Reynolds Walk" there were substituted the words "High Street"
- (o) in column 3 of Part 2 of the First Schedule for the words "Service Area's 1, 2, 3, 4 &6" there were substituted the words "Service Area Nos. 1, 2, 4 and 6"
- (p) in the first column of the Second Schedule to that Order for the numbers and letters "3282/SYH/1321 Rev A" and "3282/SYH/1324 Rev A" there were substituted respectively the numbers and letters "3282/SYH/1321 Rev B" and "3282/SYH/1324 Rev B"
- (q) for the Second Schedule to that Order there was substituted the Second Schedule set out in The Schedule to this Order
