## Citation and commencement

THIS Order may be cited as "The Surrey County Council Camberley Controlled Parking Zone in the Borough of Surrey Heath (Consolidation of Waiting and Loading and Unloading Restrictions and On-Street Parking Places) Order 2006 (Amendment No.7) Order 2013" and shall come into operation on 14 October 2013

## Interpretation

- 2 (1) In this Order "the Principal Order" means "The Surrey County Council Camberley Controlled Parking Zone in the Borough of Surrey Heath (Consolidation of Waiting and Loading and Unloading Restrictions and On-Street Parking Places) Order 2006"
  - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment
  - (3) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Order

## Amendment of The Principal Order

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of

this Order the Principal Order shall have effect as though:-
