

**THE SURREY COUNTY COUNCIL  
(VARIOUS ROADS IN SURREY HEATH)  
(WAITING LOADING AND UNLOADING PROHIBITION AND ON-STREET  
PARKING PLACES ORDERS) (AMENDMENT NO. 4) ORDER 2021**

SURREY COUNTY COUNCIL in exercise of their powers under Sections 1(1) and 2 (1) to (3) 4 32 35 36 45 46 49 51 and 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called "The Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to The Act hereby make the following Order:-

**Citation and commencement**

1. THIS Order may be cited as "The Surrey County Council (Various Roads in Surrey Heath) (Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No. 4) Order 2021" and shall come into operation on 19 November 2021\_\_\_\_\_

**Interpretation**

- 2 (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment\_\_\_\_\_
- (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment\_\_\_\_\_
- (3) Unless the context otherwise requires any expression used in this Order which is also used in the amended Order shall have the same meaning as in that Order\_\_\_\_\_

**Amendment of the Principal Orders**

3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order: -

- (a) The Surrey County Council (Various Roads in Surrey Heath) (Revocation and Consolidation of Waiting, Loading and Unloading Prohibition and Restriction) Order 2017 shall have effect as though for the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order\_\_\_\_\_
- (b) The Surrey County Council (Various Roads in Surrey Heath) (Consolidation of Free Street Parking Places and Loading Bays and Revocation) Order 2017

shall have effect as though for the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order\_\_\_\_\_

(c) The Surrey County Council (Various Roads in Surrey Heath) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2017 shall have effect as though for the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order\_\_\_\_\_

(d) The Surrey County Council (Various Roads in Surrey Heath) (Consolidation and Revocation of Residents and Shared-Use On-Street Parking Places) Order 2017 shall have effect as though -

(1) For Article 3 to the said Order there was substituted the following similarly numbered Article –

“3 EACH area on a highway -

(i) within the lengths of carriageway of the road specified in Column 3 of the table forming Part I of the First Schedule other than those identified as a zone and identified on the Plans for use by such classes of vehicles as are specified in Article 4 and unless otherwise so specified bounded on one side of that length by the edge of the carriageway and having a width throughout of not less than 1.8 metres – and

(ii) within the lengths of highway including the carriageway footway and verge of the road specified as a zone in Column 3 of the table forming Part I of the First Schedule and identified on the Plans for use by such classes of vehicles as are specified in Article 4

- is hereby designated as a residents' parking place”

(2) For Part I of the First Schedule to the said Order there was substituted the First Schedule to this Order

(3) for the List of Plans in the Second Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order

(e) The Surrey County Council (Various Roads in Surrey Heath) (Consolidation and Revocation of Prohibition of Stopping Outside Schools) Order 2017 shall have effect as though

(i) For the Third Schedule to the said Order there was substituted the Second Schedule to this Order

(ii) for the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order

(f) The Surrey County Council (Various Roads in Camberley) (Prohibition of Waiting) (Restricted Zone) (Revocation and Consolidation) Order 2017 shall

have effect as though for the List of Plans in the First Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order \_\_\_\_\_

(g) The Surrey County Council Camberley Controlled Parking Zone in the Borough of Surrey Heath (Consolidation and Revocation of Waiting Loading and Unloading Restrictions and On-Street Parking Places) Order 2017 shall have effect as though

(i) The words “or within the area labelled as a Restricted Zone within the said Camberley Controlled Parking Zone” were inserted in Article 3 immediately following the words “Controlled Parking Zone”

(ii) for the List of Plans in the Second Schedule to the said Order there was substituted the List of Plans set out in the Third Schedule to this Order
