Citation and commencement

- This Order may be cited as "The Surrey County Council (Various Roads in Surrey Heath) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Order) (Amendment No.5) Order 2023" and shall come into operation on ...
- 2 (1) In this Order the expression
 - "enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment
 - "Principal Order" means each of the relevant Principal Orders listed in Article 3(A) Article 3(B) Article 3(C) Article 3(D) Article 3(E) Article 3(F) and Article 3(G)
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
 - (3) Unless the context otherwise required any expression used in this Order which is also used in the specified Principal Order shall have the same meaning as in the said Principal Order


