THE SURREY COUNTY COUNCIL in exercise of their powers under Sections 1 (1) and 2 (1) to (3) and 4(2) and 32 35 and 36 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

Citation and commencement

1 THIS Order may be cited as "The Surrey County Council (Various Roads in Tandridge) (Amendment of Waiting Loading and Unloading Prohibition and Restriction and Free On-Street Parking Place Orders) (Amendment No. 1) Order 2008" and shall come into operation on 31 March 2008

Interpretation

- 2 (1) In this Order the expression "enactment" means any enactment whether public general or local and includes any order byelaw rule regulation scheme or other instrument having effect by virtue of an enactment
 - (2) In this Order the expression "the No. 1 Order of 2006" means The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places) Order 2006
 - (3) In this Order the expression "the No. 2 Order of 2006" means The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2006
 - (4) In this Order the expression "the No. 3 Order of 2006" means The Surrey County Council (Various Roads in Tandridge) (Consolidation of Free Street Parking Places) (Disabled Persons) (No. 1) Order 2006
 - (5) In this Order the expression "the No. 4 Order of 2006" means The Surrey County Council (Various Lay-bys in Tandridge and Westway (D1399) Caterham

- on the Hill) (Free Street Parking Places) Order 2006
- (6) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated re-enacted by or as having effect by virtue of any subsequent enactment
- (7) Unless the context otherwise requires any expression used in this Order which is also used in the No. 1 Order of 2006 the No. 2 Order of 2006 the No. 3 Order of 2006 and the No. 4 Order of 2006 shall have the same meaning as in each of those Orders

- WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the No. 1 Order of 2006 the No. 2 Order of 2006 the No. 3 Order of 2006 and the No. 4 Order of 2006 shall have effect as though:-
- (a) in paragraph (1) of Article 2 the expression "parking attendant" and the meaning assigned thereto was deleted in its entirety
- (b) in paragraph (1) of Article 2 there were added the following expressions -
 - " "penalty charge notice" has the same meaning as in the General Regulations

 "civil enforcement officer" has the same meaning as in Section 76 of the Traffic

 Management Act 2004
 - "the General Regulations" means The Civil Enforcement of Parking Contraventions (England) General Regulations 2007 (S.I. 2007/3483)

person authorised in that behalf by the Council or its Agents or a police constable in uniform or a civil enforcement officer may remove the vehicle or arrange for it to be moved from that parking place

PROVIDED THAT where a vehicle is waiting in a parking place in contravention of the provision of Article 29(b) a person authorised in that behalf by the Council or its Agents or a police constable in uniform or a civil enforcement officer may alter or cause to be altered the position of the vehicle in order that its position shall comply with that provision

BUT PROVIDED ALSO THAT civil enforcement officers shall not exercise the powers in this Article other than in accordance with the 1986 Regulations"

- (f) in Article 40 in the first line thereof after the words "or a police constable in uniform" there were added the words "or a civil enforcement officer"
- (g) in Article 48 for the words "parking attendant" there were substituted the words "Civil Enforcement Officer"
